Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Roads Act 1993*.

Explanatory note

The object of this Regulation is to declare the Roads and Traffic Authority to be the roads authority for certain public roads, being parts of the Alpine Way and Kosciuszko Road within the Kosciuszko National Park.

This Regulation is made under the *Roads Act 1993*, including sections 7 and 264 (the general regulation-making power).

1 Name of Regulation

This Regulation is the *Roads (General) Amendment (Alpine Way Declaration) Regulation 2004*.

2 Commencement

This Regulation commences on 17 May 2004.

The *Roads (General) Regulation 2000* is amended as set out in Schedule 1.

Clause 79C

Insert after clause 79B:

79C Roads authority for public roads (Alpine Way and Kosciuszko Road)

- (1) The RTA is declared to be the roads authority for the following public roads:
 - (a) the public road shown as Lots 401–417 on Plan No 0677.435.SS.0006, Lots 501–522 on Plan No 0677.435.SS.0007, Lots 601–605 on Plan No 0677.435.SS.0008, Lot 701 on Plan No 0677.119.SS.0001, Lots 801–809 on Plan No 0677.119.SS.0002 and Lot 901 on Plan No 0677.435.SS.0010 (that public road being the Alpine Way within the boundary of the Kosciuszko National Park), and
 - (b) the public road shown as Lots 101–107 on Plan No 0286.119.SS.0129, Lot 201 on Plan No 0286.119.SS.0130 and Lots 301–313 on Plan No 0286.119.SS.0131 (that public road being the Kosciuszko Road within the Kosciuszko National Park).
- (2) In this clause, a reference to a Plan is a reference to a plan held at the Regional Client Services Office of the RTA, Level 1, 140 Kembla Street, Wollongong.

ROADS ACT 1993

Order - Sections 46, 49, 54 and 67

Tumbarumba Shire and Snowy River Shire Council areas

Dedication of Land as Public Road and Declaration as Controlled Access Road of Alpine Way and Kosciuszko Road within the Kosciuszko National Park

I, the Minister for Roads, pursuant to Sections 46, 49, 54 and 67 of the Roads Act, 1993, by this order -

1. dedicate as public road the land described in the Schedule under;
2. declare to be main road the said public road described in the Schedule;
3. declare to be controlled access road the said main road described in the Schedule; and
4. declare that access to the said controlled access road is restricted.

<u>NAME AND NUMBER</u>	<u>DESCRIPTION</u>
Main Road No 677	Alpine Way – From Kosciuszko Road (MR286) at approximately 3 km west of Jindabyne, via Penderlea, Bullocks Flat, Thredbo, Dead Horse Gap, Tom Groggin, and Geehi to the Kosciuszko National Park Boundary at approximately 400 metres west of the crossing of Khancoban Creek east of Khancoban.
