SPECIAL SUPPLEMENT

ELECTRICITY SUPPLY ACT 1995

Section 119(1)(a)

ORDER

I, ANTHONY JOHN ROBERTS, M.P., Minister for Resources and Energy, pursuant to section 119(1)(a) of the Electricity Supply Act 1995 (the Act), declare as follows:

1. Each electricity load used by the persons specified in the Schedule, including any related bodies corporate, ('specified person'), at the locations set out in the Schedule, is either fully or partially exempt from the Energy Savings Scheme in Part 9 of the Act, as specified in the fourth column of the Schedule. For partial exemptions, the exempt portion of each electricity load is specified in the Schedule as a percentage ('exempt proportion').
2. In applying the exemption granted by paragraph 1 of this Order a scheme participant may deduct from the total value of its liable acquisitions an allowance of 5% of the exempt proportion for losses occurring between the purchase of electricity by the scheme participant and its use by the specified person.
3. The exemption granted by paragraph 1 of this Order is effective from 1 January 2014 until revoked. All previous orders are revoked on and from 1 January 2014.
4. The Scheme Regulator, pursuant to Section 120(5) of the Act, is authorised to make rules with respect to the exemption granted by paragraphs 1 and 2 of this Order (including rules relating to assessment of deductions under Division 5 of the Act).

I am satisfied that each electricity load to which this Order applies is used in connection with an industry or activity that is both emissions intensive and trade exposed and that the exemption is generally consistent with the objects of Part 9 of the Act.

Factual circumstances that give rise to the suspension	Without further action, Council's financial position has deteriorated significantly with a current forecast deficit in operating funds of \$3.1M in May 2014. Council's financial position is expected to worsen further over the medium to long term. Councillors do not appear to have the capacity or willingness to sustain strict financial controls.
Reasons for order – suspension criteria – Clause 413E Local Government (General) Regulation 2005	<ul style="list-style-type: none"> • Council has failed to comply with its legislative responsibilities in relation to financial management • There are significant financial risks facing the Council that are not being addressed • Previous intervention attempts have failed to rectify the financial circumstances • The appointment of an interim administrator is necessary to secure Council's finances and restore the proper or effective functioning of the Council
Period of suspension	3 months from the publication of this order in the Gazette or such earlier time if the suspension is terminated by order.
Terms of appointment of interim administrator	<p>Pursuant to section 438M of the Local Government Act, Greg Wright, is appointed as interim administrator of Central Darling Shire Council for the period of the suspension, commencing on the date of the publication of this order in the Gazette and shall have the following functions:</p> <ul style="list-style-type: none"> • To perform the role and function of the governing body of the Council under the Local Government Act and any other Act. • To exercise the role of the governing body and councillors identified in sections 223, 232(1) and 226 of the Local Government Act. <p>Pursuant to section 438M(7) of the Local Government Act, the interim administrator shall be paid a salary of \$23,600.00 from the Council's funds for the period of the suspension.</p>
Reporting timeframes for interim administrator	<p>Provide brief weekly written reports (by email) on Council's position and any findings to the Chief Executive, Local Government.</p> <p>Provide a final report and any recommendations, pursuant to section 438N of the Local Government Act.</p>
