### Citation

This Notice may be cited as the Roads and Maritime Services Class 2 Road Train (Amendment) Notice No. 4/2013.

This Notice takes effect on and from midnight on 7 February 2014 up to midnight on 9 February 2014 unless it is repealed earlier.

#### **SCHEDULE**

#### Part 1 – Preliminary

#### 1.1 Citation

This Notice may be cited as the 4.6 Metre High Vehicle Amendment Notice 2014.

#### 1.2 Commencement

This Notice takes effect on 9 February 2014.

#### 1.3 Effect

The 4.6 Metre High Vehicle Notice 2013 published in the New South Wales Government Gazette No. 130 on 21 December 2012 at pages 5109 to 5206 remains in force subject to the amendments contained in this Amendment Notice.

#### 1.4 Interpretation

- (a) Unless stated otherwise, words and expressions used in this Notice have the same meaning as those set out in the Road Transport (Vehicle and Driver Management) Act 2005.
- (b) Unless stated otherwise, notes in this Notice do not form part of this Notice.

*Note:* The Heavy Vehicle National Law (HVNL) is in force with effect on and from 10 February 2014. The following Notices made under the HVNL deal with 4.6 metre high vehicles:

- (i) National Class 3 Heavy Vehicle 4.6m High by Construction Semitrailer Dimension Exemption (Notice) No. 1, 2014;
- (ii) National Class 2 Heavy Vehicle 4.6m High and/or 25m Long Vehicle Carrier Authorisation (Notice) No. 1, 2014;
- (iii) National Class 2 Heavy Vehicle 4.6m High Livestock Carrier Authorisation (Notice) No. 1, 2014;
- (iv) New South Wales and Queensland Class 3 Heavy Vehicle 4.6m High Loaded Semitrailer Exemption (Notice) 2014;
- (v) National Class 3 Heavy Vehicle Vehicle Carrier Exemption (Notice) 2014 (No.1);
- (vi) National Class 2 Heavy Vehicle B-double Authorisation (Notice) 2014 (No.1); and
- (vii) National Class 2 Heavy Vehicle Road Train Authorisation (Notice) 2014 (No.1)

The amended NSW 4.6 Metre High Vehicle Notice 2013 will deal with Class 1 vehicles and certain Class 3 vehicles not covered by these HVNL Notices.
