FISHERIES MANAGEMENT ACT 1994

Instrument Of Determination

Total Allowable Catch for Abalone

I, Niall Mark Blair MLC, Minister for Primary Industries pursuant to section 33 of the *Fisheries Management Act 1994* ("the Act"), provide notice that the Total Allowable Catch Setting and Review Committee established under section 26 of the Act:

- 1. pursuant to sections 28 and 33 of the Act, revokes the determination titled "Instrument of Determination Total Allowable Catch for Abalone" dated 5 December 2014 and published in *NSW Government Gazette* No 119 of 12 December 2014 at page 4447, and any determination revived as a result of this revocation; and
- 2. pursuant to section 28 of the Act and clause 14 of the Appendix to the *Fisheries Management (Abalone Share Management Plan) Regulation 2000*, determines that the total allowable catch for abalone for the fishing period beginning 1 January 2016 and ending 31 December 2016 (both dates inclusive) is 130 tonnes.

This Instrument of Determination takes effect on 1 January 2016.
