Withdrawal of Drug Authority

SUSPICIOUS DISAPPEARANCE

One Hundred Thousand Dollars (\$100,000) Reward

In June 2013, Cheryl ARDLER was reported missing to police. She was last seen in December 2012 in Cranebrook, New South Wales. She is believed to have been murdered sometime after December 2012. Her remains have never been located.

Notice is hereby given that a reward of up to one hundred thousand dollars (\$100,000) will be paid by the Government of New South Wales for information leading to the arrest and conviction of the person or persons responsible for the suspicious disappearance of Cheryl ARDLER.

The allocation of this reward will be at the sole discretion of the Commissioner of Police.
