#### 2015 Election of Four (4) Members to the Board

#### Election Notice

Pursuant to section 9A (b) of the *Lord Howe Island Act 1953* No 39, the Electoral Commissioner for New South Wales shall conduct an election for the purpose of determining the Islanders to be appointed to the Lord Howe Island Board pursuant to section 4 (3) (a) of the Act.

# Nominations

## Nominations are hereby invited on and from Friday, 9 January 2015 to elect Four (4) members to the Board.

To be eligible for nomination, a candidate must be an Islander as defined in the *Lord Howe Island Act 1953* and be enrolled as an elector for the election.

A candidate at an election shall be nominated by at least 2 persons (other than the candidate) who -

- (a) are enrolled as electors for the election; and
- (b) have not, by that nomination and any other previous nomination in respect of the election, nominated more candidates than there are persons to be elected, i.e. four (4) persons.

## Lodgement of Nominations

Completed Nomination Forms must be received by the Returning Officer, NSW Electoral Commission by **no later than 12.00 Noon, Friday 23 January 2015**.

Nomination forms can only be lodged with the Returning Officer at the NSW Electoral Commission:

Any defect in a nomination must be rectified by the candidate prior to the close of nominations **12.00 Noon, Friday 23 January 2015**. A candidate may only withdraw a nomination in writing so as to be received by the Returning Officer, prior to the close of nominations.

Should the election be contested, a draw to determine the order of candidates' names on the ballot paper will be conducted at 2.00pm, Friday 23 January 2015 by the Deputy Returning Officer, Lord Howe Island Board Administration Office. Candidates or their representatives are invited to witness the draw.

## Voting

If more than the required number of nominations is received, a poll will be held between the hours of: **8.00am and 6.00pm on Thursday 12 February 2015.**
