### FISHERIES MANAGEMENT ACT 1994

Section 8 Notification – Fishing Closure

Pipis

I, Niall Mark Blair, MLC, Minister for Primary Industries, pursuant to section 8 of the *Fisheries Management Act 1994* (‘the Act’) do by this notification prohibit the taking of pipis (*Donax deltooides*), by holders of a hand gathering endorsement in the Estuary General Fishery, by the method of hand picking, from all waters.

In this fishing closure:

**hand gathering endorsement** has the same meaning as in clause 6 of the Appendix to the *Fisheries Management (Estuary General Share Management Plan) Regulation 2006*.

**Estuary General Fishery** means the share management fishery of that name, as described in Schedule 1 to the Act.

The provisions of this fishing closure have effect in respect of holders of a hand gathering endorsement in the Estuary General Fishery despite any provisions in the *Fisheries Management (Estuary General Share Management Plan) Regulation 2006*.

This fishing closure is effective from the date of gazettal of the closure notification and remains in force until 31 May 2016, unless sooner amended or revoked.

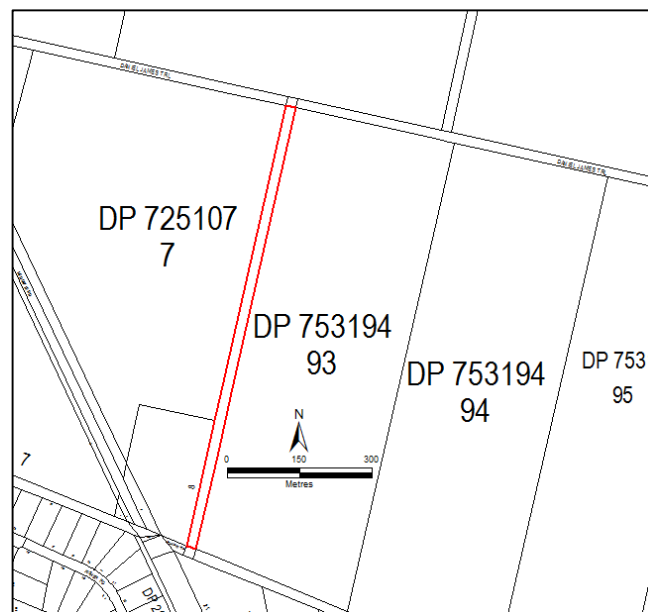

### FLUORIDATION OF PUBLIC WATER SUPPLIES ACT 1957

#### Direction to Add Fluorine to a Public Water Supply (Lachlan Shire Council – Lake Cargelligo)

I, Dr Kerry Chant, Chief Health Officer and Deputy Secretary Population and Public Health, NSW Ministry of Health, with the advice of the Fluoridation of Public Water Supplies Advisory Committee, and pursuant to section 6A of the *Fluoridation of Public Water Supplies Act 1957*, do hereby direct Lachlan Shire Council, a water supply authority, to add fluorine to the water supply under its management and control supplied from the Lake Cargelligo water treatment plant (in this direction referred to as the “Lake Cargelligo water supply”).

This direction is subject to the following terms and conditions:

1. Lachlan Shire Council may only add fluorine to the Lake Cargelligo water supply in accordance with any provisions, directions or approvals made under the *Fluoridation of Public Water Supplies Act 1957*, the *NSW Code of Practice for the Fluoridation of Public Water Supplies* made under that Act as amended from time to time, and the *Fluoridation of Public Water Supplies Regulation 2012* or any subsequent Regulation made in its place
2. Lachlan Shire Council shall maintain the content of fluorine in the Lake Cargelligo water supply at a target concentration level of 1.0 mg/L (ppm) with an overall accuracy of +/- 5% and within an operating range of not more than 1.5 mg/L and not less than 0.9 mg/L and generally in accordance with the relevant provisions of the *NSW Code of Practice for the Fluoridation of Public Water Supplies*.
3. Lachlan Shire Council is prohibited from adding to the Lake Cargelligo water supply fluorine in a form other than sodium fluoride.
4. Lachlan Shire Council shall have commenced the upward adjustment of fluorine in the Lake Cargelligo water supply by no later than 28 February 2017, unless otherwise approved by the Chief Health Officer or that officer’s approved representative.

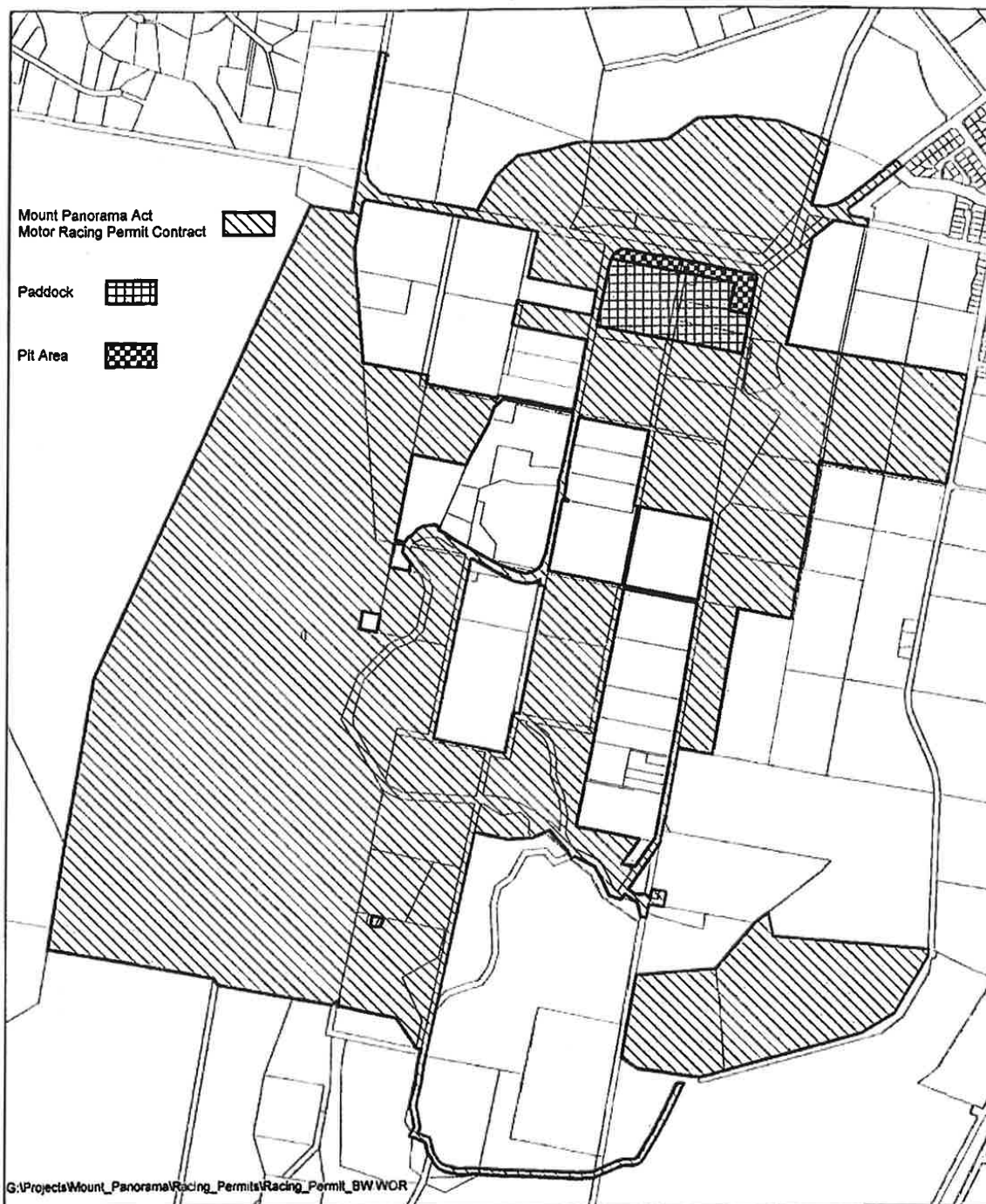
