STOCK DISEASES ACT (JOHNE'S DISEASE IN CATTLE) REVOCATION OF NOTIFICATION 2016

under the

STOCK DISEASES ACT 1923

I, Niall Blair, MLC, Minister for Primary Industries, pursuant to sections 3 (2) (a) and 11A of the *Stock Diseases Act 1923*, revoke Notification No 1826-BJD published in *NSW Government Gazette* No 77 of 24 July 2012 at page 3416, which declared New South Wales to be a Protected Area as regards Johne's disease in cattle (commonly known as bovine Johne's disease), and any notification revived as a result of this revocation.

This notification takes effect on 1 July 2016 or the date on which it is gazetted, whichever is the later date.
