Section 12(2)

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Brisk Bay, near the township of Patonga, extending 150 meters beyond the moored vessels.

Duration

7.00pm to 7.10pm on Saturday 23 September 2017.

Detail

A fireworks display will be conducted from a barge on the waters of Brisk Bay, Patonga at the location described above. The area directly around the moored firing barge may be dangerous and hazardous while fireworks are being launched.

An **EXCLUSION ZONE** is specified during the event, which will form an area of the waterway around the firing barge and will be marked by control vessels.

Vessel operators must keep a proper lookout and should exercise caution near the exclusion zone.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone, which will be patrolled by control vessels.

Penalties may apply (section 12(5) – *Marine Safety Act 1998*)
