## Detail

Trials will be conducted on the waters of Blowering Dam as specified above, involving the use of a high speed vessel powered by a jet engine which will be active on the waterway at varying times on the days specified above. There will be support and official vessels present to manage the trials and the jet powered vessel will be operating at very high speed and presenting a significant potential hazard to other waterway users.

*ballot allowance* for an estuary general prawning fishing business – see clause 35J(1) of the EG Plan.

*estuary general fishery* means the share management fishery of that name, as described in Schedule 1 to the Act.






