PESTICIDES REGULATION 2017

Clause 31(1)

NOTICE OF APPROVED QUALITY ASSURANCE AND STEWARDSHIP PROGRAMS

Background

The *Pesticides Regulation 2017* ('the Regulation') provides that certain users of pesticides must be qualified to use pesticides. Users described in clause 32(1) of the Regulation who are not required to have a licence issued under the *NSW Pesticides Act 1999* are generally required to have achieved certain units of competency and to have these competencies reassessed every five years.

Clause 31(1)(c) of the Regulation provides an alternative to the five yearly reassessment requirement if a pesticide user has:

- participated in a quality assurance or stewardship program ('programs') relating to the use of pesticides which has been approved by the Environment Protection Authority (EPA) by notice published in the Gazette, and
- has complied with any conditions required by the notice in relation to that program.

The NSW EPA Board has endorsed a *Quality Assurance and Stewardship Program Approval Policy* (November 2017) which is available on the NSW EPA website www.epa.nsw.gov.au and this approval has been developed with reference to the Policy.

Before granting this approval the NSW EPA:

- has sought comment by relevant groups; and
- is satisfied that the requirements of the approved programs are relevant to the objects of the *Pesticides Act 1999* and *Pesticides Regulation 2017*.

Approved quality assurance and stewardship programs

For the purposes of clause 31(1)(c)(i) of the Regulation, the following programs are approved by the NSW EPA:

- Freshcare Food Safety & Quality (FSQ4 Code) and Environmental (ENV3 Code)
- Global G.A.P. (Good Agricultural Practice) Integrated Farm Assurance Crops Base and Livestock modules
- Graincare
- Livestock Production Assurance Quality Assurance
- National Feedlot Accreditation Scheme
- SQF Code (Safe Quality Food) modules 3, 5, 7 and 8

Murray River – near Albury. The entire width of the river from the Hume Weir Wall (downstream) to Noreuil Park.

Duration

- 3:00pm to 8:00pm Saturday 10 February 2018
 - 9:00am to 2:00pm Sunday 11 February 2018

Detail

A canoe and kayak event will be conducted on the waters of the Murray River between the points specified above.

Due to the risk to safe navigation and as a result of the nature and number of participating vessels, a Regulated Area will be created between the above times and will comprise the full width of the River between the locations detailed above. The Regulated Area will extend 200 metres ahead and 200 metres behind the competing vessels (as indicated by the presence of official vessels) and will surround and move with the competing vessels over the length of the course.

Special Restrictions

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, all **powered vessels** operating in the Regulated Area must not exceed a speed limit of 4 knots and must produce only minimal wash.

ORDER No.3

Recognition of existing qualifications for eligibility for underground mine supervisor of an underground mine other than coal mines

- I, MELANIE BROWN, Director Mine Safety Performance, with the delegated authority of the Secretary, Department of Planning and Environment, pursuant to clause 20(2) and clause 21(1) of Schedule 12 to the *Work Health and Safety (Mines and Petroleum Sites) Regulation 2014* declare that:
- 1. a former certificate listed in Column 1 of Schedule 1 and 2 of this declaration is equivalent to the practising certificate(s) listed opposite in Column 3 of Schedule 1 and 2;
- 2. a certificate of competence listed in Column 2 of Schedule 1 of this declaration is equivalent to the practising certificate(s) listed opposite in Column 3 of Schedule 1;
- 3. pursuant to clause 20(5) of Schedule 12 to the *Work Health and Safety (Mines and Petroleum Sites) Regulation* 2014, this Order applies to a former certificate in Column 1 that is granted by virtue of clause 23 of Schedule 12, even if the former certificate was awarded after the commencement of this Regulation; and
- 4. pursuant to clause 20(6) of Schedule 12 to the *Work Health and Safety (Mines and Petroleum Sites) Regulation* 2014, a certificate of competence or practising certificate specified in Schedule 2 remains subject to any condition or limitation to which the former certificate was subject.

In this Order, 'former certificate' has the same meaning as in clause 20(1) of Schedule 12 of the *Work Health and Safety (Mines and Petroleum Sites) Regulation 2014*.

This Order replaces the recognition of existing qualifications and other related matters by the Order published in the NSW Government Gazette No 8 of 30 January 2015 but only in respect of recognising the certificate of competence for production manager for an underground mine, certificate of competence for mining engineering manager of an underground mine other than coal mines, and production manager permit to be a practising certificate for the underground mine supervisor as detailed in clause 26 of Schedule 10 of the *Work Health and Safety (Mines and Petroleum Sites) Regulation 2014*.






