## Protection of the Environment Operations Act 1997

### Order granting exemption under section 284

#### Background

- a. 7-11 Stores Pty. Ltd. has made application for exemption from provisions of the Protection of the Environment (Clean Air) Regulation 2010 to install prescribed control equipment for petrol dispensers at:
  - i. Highway Service Centre - Lot 12, DP 773041, South Western Freeway (Hume Hwy), Southbound, Pheasants Nest, NSW 2574 (Lot 12 DP773041)
  - ii. Highway Service Centre - Lot 1, DP 1147096, South Western Freeway (Hume Hwy), Northbound, Pheasants Nest, NSW 2574 Lot 1 DP1147096)
- b. Both sites are currently leased from Roads and Maritime Services (RMS) with leases which expire in January 2019.
- c. With limited certainty of tenure, 7-Eleven Stores Pty. Ltd. has been reluctant to proceed with installing vapour recovery stage 2 control equipment (VR2).
- d. 7-11 Stores Pty Ltd has committed to installing VR2 at both sites once occupation rights for both premises has been secured.
- e. 7-Eleven Stores Pty Ltd has a demonstrated commitment to meeting its VR requirements with 180 sites across Sydney, Central Coast, Newcastle and Wollongong Metropolitan areas already VR compliant.

#### REGULATION OF VESSELS – EXCLUSION ZONE

##### **Location**

Lake Wyangan, Griffith

##### **Duration**

7.00am to 6.00pm – Saturday 10 March and Sunday 11 March 2018.

##### **Detail**

Competitive powerboat races will be conducted on the navigable waters of Lake Wyangan on the above dates. High speed power vessels will be active in the area during the event, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the entirety of Lake Wyangan. This will (in effect) close the Lake between the above times for this event. The zone will also be patrolled by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

Manning River, Taree – Adjacent to Queen Elizabeth Park, between Goat Island & Endeavour Place Boat ramp.

##### **Duration**

7.00am to 5.30pm – Saturday 10 March 2018

7.00am to 5.30pm – Sunday 11 March 2018

##### **Detail**

A rowing regatta will be conducted on the navigable waters of Manning River as specified above.

An **EXCLUSION ZONE** is specified during the event. The exclusion zone will be marked by course buoys and control vessels that will shadow the rowing sculls throughout the event.

Control vessels will, at times during the event, authorise local vessel traffic to transit the exclusion zone during breaks in the event.

All vessel operators and persons in the vicinity of the event should comply with directions issued from control vessels, keep a proper lookout, keep well clear of competing and support vessels and exercise extreme caution at all times when navigating near the exclusion zone.

**Part 1 – Administrative**

**1 Citation**

This Order is the *Ministerial (Automated Vehicle Trial – Smart Shuttle Sydney Olympic Park) Order 2018*

**2 Commencement**

This Order takes effect from the date of its publication in the NSW Government Gazette.

**3 Effect**

This Order remains in effect until 1 July 2019 unless revoked earlier.

**4 Interpretation**

Words and expressions used in this Order have the same meaning as in road transport legislation, unless otherwise stated.

**5 Definitions**

In this Order:

***trial safety and traffic management plan*** means the documents developed in consultation between the approved person, Transport for NSW and Roads

and Maritime Services, however identified, which describe the safety and traffic management arrangements for the conduct of the trial.

**Sydney Olympic Park major event bus service** means any bus operating on routes 1A, 1B, 2, 4, 5A, 5B, 6, 7, and 8 to and from Sydney Olympic Park.

**Part 2 – Approval details**

**6 Trial vehicle**

The trial vehicle is a Navya Arma Shuttle with Vehicle Identification Number: VG9A3CB3DHB019025.

**7 Approved person**

The approved person is HMI Technologies Pty Ltd – ACN: 155 249 031.

**8 Responsibility for vehicle**

8.1 A vehicle supervisor must be in the vehicle at all times when the vehicle is in use and must hold as a minimum a current Australian driver licence Class C.

8.2 The **driver** of the vehicle is:

- (a) the vehicle supervisor when the vehicle is not in automated mode; or
- (b) if the vehicle is in automated mode, the approved person.

8.3 The **person in charge** of the vehicle in all modes of operation is both:

- (a) the vehicle supervisor; and
- (b) the approved person.

**9 Road Transport Legislation exemption**

9.1 Passengers in the trial vehicle 16 years old or older are not required to comply with rule 265 of the Road Rules 2014 provided each passenger otherwise complies with rule 267(6–1) even though the trial vehicle is not a public bus.

9.2 A vehicle supervisor is exempt from rules 264, 265(3), 266 and 299 (1) of the Road Rules 2014.

9.3 A vehicle supervisor is not required to comply with rule 100 of the Road Rules 2014 in order to enter the “Holker Busway” at Sydney Olympic Park between Kevin Coombes Avenue and Hill Road when a Sydney Olympic Park major event bus service is not operating.

9.4 A vehicle supervisor is not required to comply with rule 154 of the Road Rules 2014 when travelling on Holker Street between Jamieson Street and Hill Road or Kevin Coombes Avenue when a Sydney Olympic Park major event bus service is not operating.

*Note: Clause 9 of the Order has effect pursuant to Road Transport Act 2013 section 19 – Power of Minister to exclude vehicles, persons or animals. The clause exempts standing passengers in the trial vehicle from the Road Rules 2014 requirement to wear a seat belt; exempts young passengers from the requirement to use a booster seat; exempts the vehicle supervisor from wearing a seatbelt; exempts the vehicle supervisor by ensuring seatbelt rules are complied with by passengers; exempts the driver from the requirement of driving with a VDU*

*operating; allows the vehicle to travel in a bus lane; and to enter the Holker Busway by passing a no entry sign.*

**Part 3 – Operating conditions**

Note: The Minister may under Part 5.6 of the *Road Transport Act 2013* impose conditions on a trial approval and the manner and circumstances in which the trial is to be conducted (in addition to the statutory conditions imposed by that Act).

**10 Vehicle standards and performance**

- 10.1 The vehicle must be suitable for safe use and in a thoroughly serviceable condition.
- 10.2 The trial vehicle is to be registered subject to the following conditions:
  - (a) L03 – The trial vehicle may be operated only within the trial area as stated in clause 11 of this Order;
  - (b) SL5 – Slow vehicle sign;and the Authority is directed to register the trial vehicle accordingly.

**11 Trial area**

- 11.1 The trial vehicle must only be operated or used on road or road related areas marked red, blue and green as shown on the map titled “Sydney Olympic Park Designation of Roads” in Schedule 1 to this Order (the **trial area**).
- 11.2 The trial will be conducted in stages and will progress from one stage to the next only when Transport for NSW is satisfied the trial vehicle has been assessed as capable of operating in accordance with the trial safety and traffic management plan as applicable for each stage of the trial.
- 11.3 The trial vehicle is approved to operate in the following areas:
  - (a) Stage 1 – Newington Armory: Sealed road, closed to the public during the operation of the trial vehicle.  
Stage 2 – a loop of approximately one kilometre along Olympic Boulevard, between Kevin Coombs Avenue and Dawn Fraser Avenue.
- 11.4 The trial vehicle may, when at Stage 2, operate on roads within the trial area for the purpose of mapping, testing and verifying of data for the purpose of further trial stage but only in accordance with a Traffic Control Plan approved by Transport for NSW.

**12 Passengers**

- 12.1 Passengers less than one year of age are not permitted to ride in the trial vehicle.
- 12.2 Passengers one year old or older but less than seven years old may ride in the vehicle only when:
  - (a) the trial vehicle is operated on a closed public road;
  - (b) the maximum speed of the trial vehicle travels no more than 20 km/h;
  - (c) the trial vehicle is limited to accelerating with a force less than 0.52g (Note: whether the direction the force is applied is positive or negative, it must be less than 0.52g);
  - (d) the passenger occupies a rearward facing seating position fitted with a



- seat belt and is wearing the seat belt;
  - (e) the vehicle supervisor is in the trial vehicle; and
  - (f) the passenger is accompanied by a supervising passenger who is over the age of 16, and is not the vehicle supervisor.
- 12.3 Passengers seven years old or older but less than 16 years old:
- (a) must occupy a seating position and wear a seatbelt; and
  - (b) are not permitted to ride in the trial vehicle as a standing passenger.
- 12.4 No more than 14 persons, including the vehicle supervisor, are allowed to ride in the trial vehicle.

**13 Promotional and display activities**

For the purpose of any promotion or display, the trial vehicle may:

- (a) stand on any road or road related area in accordance with any applicable prescribed traffic control devices; and
- (b) be operated outside the trial area to load or unload the trial vehicle from another vehicle.

*Note: clause 13 of the Order has effect pursuant to Road Transport Act 2013 section 19 – Power of Minister to exclude vehicles, persons or animals.*

**14 Trial Safety and traffic management plans**

- 14.1 The trial vehicle must be used and operated in accordance with the trial safety and traffic management plan.
- 14.2 The trial safety and traffic management plan must include a general risk analysis (identifying, assessing hazards and controlling risks) including the matters listed in paragraph 5.2 of the *Guidelines for trials of automated vehicles in Australia* published by Austroads and the National Transport Commission in 2017.

**15 Operating reports**

- 15.1 **Notification obligations** – the approved person must notify and submit a report to Transport for NSW for each incident of the following types of incidents within the stated time period from the relevant incident:

- (f) number of passengers, seating position and use of restraints by each passenger and age of each passenger;
- (g) traffic conditions (for example, empty road, in heavy traffic, etc);
- (h) road and weather conditions;
- (i) vehicle information (for example vehicle speed, brake/throttle applications, vehicle fault condition description, etc);
- (j) sensor information in relation to other road users and the surrounding road environment;
- (k) description of reported incident and
- (l) classification of the incident type as determined in consultation with TfNSW.

## 16 Security breach reporting to NSW Police Force

16.1 Any event involving unplanned or unauthorised access to or control of the trial vehicle by any person other than the vehicle supervisor or approved person must be reported to NSW Police Force upon detection of the breach.

The approved person must provide reports as agreed with TfNSW and RMS.

*the Act* means the *Exhibited Animals Protection Act 1986*.

*the Animal Welfare Unit* means the Animal Welfare unit of the Animal Biosecurity and Welfare branch of the Biosecurity and Food Safety division of the NSW Department of Primary Industries, being an office of the Department.

*the Department* means the Department of Industry.

*the Regulation* means the Exhibited Animals Protection Regulation 2010.

*the Standards* means any Standard prescribed in clause 8 of the Regulation.

- (2) Unless otherwise defined in this Instrument, words and expressions that are defined in the Act have the same meaning in this Instrument.
- (3) Unless otherwise specified, references to a role or role title in this Instrument are references to a role or role title within the Department.

- (4) The summary of a function delegated in Column 2 of Schedules 1 and 2 is only for general explanation and does not limit the delegation of functions under the sections identified in Column 1 of those Schedules.

#### **4 Delegation of functions**

- (1) Pursuant to section 49A of the Act and subject to clauses 4(2) and 4(3) below:
- (a) all of the functions conferred or imposed on the Secretary under the Act (other than the power of delegation) and the Regulation are delegated to the person assigned to the role having the title Director General, NSW Department of Primary Industries;
  - (b) the functions conferred or imposed on the Secretary under the Act in Column 1 of Schedule 1 and under the Regulation in Column 1 of Schedule 2 are delegated to any person assigned to the role having the title specified in Column 3 of Schedules 1 and 2 respectively;

**CHARITABLE TRUSTS ACT 1993**

NOTICE UNDER SECTION 15

CY PRÈS SCHEME RELATING TO  
THE ESTATE OF THE LATE DR WILLIAM LEONARD MAYO

Section 9(1) of the *Charitable Trusts Act 1993* permits the application of property cy-près where the spirit of the original trust can no longer be implemented.

Dr Mayo was the founder and president of the American Society for Environment Education ('ASEE') and the Australian Society for Environmental Education ('the Australian Society'). The Executor of Dr Mayo's estate commenced proceedings in the Supreme Court for judicial advice in relation to matters concerning Dr Mayo's estate and Dr Mayo's will.

In accordance with the decision of the Supreme Court in *In Application by Latham as Executor of the estate of the late William Leonard Mayo* [2016] NSWSC 1811, Dr Mayo held the sum of \$25,000 as trustee for ASEE, to be utilised for relocating ASEE to San Francisco upon Dr Mayo's death or resignation as president of the ASEE. In that decision, Steven J found that that as the ASEE no longer exists, there can be no question of relocation. Steven J further held that that trust was a charitable trust, with the objects of the ASEE being the promotion of environmental education in the nation's schools and colleges and amongst the corporate community and general public.

By order dated 13 December 2016, Steven J directed that the sum of \$25,000 should be set aside from the assets to be applied by way of a cy prè scheme for the purposes of the ASEE.

The Outreach Program of the Environmental Defenders Office Ltd (ABN 72002880864) ('EDO NSW') has been identified as having a similar purpose to the ASEE. The objects of the EDO NSW include promoting community educational programs in matters relating to environmental law. The scope of the Outreach Program extends to a wide range of groups including schools, universities, community groups, environmental professionals, and people who make decisions impacting on the environment, including local and state government employees. This aligns with the original purpose of the ASEE, being to foster and promote environmental education in schools, colleges, the corporate community, and the general public.

The executor of the estate has no objection to a cy prè scheme applying the funds to EDO NSW for its Outreach Program.

In circumstances where the trust property cannot be applied to the original purpose of the ASEE, since the ASEE has ceased to exist, the Solicitor General, as the Attorney General's delegate has agreed with a recommendation that the trust should be applied cy prè for the EDO NSW Outreach Program, that being as close as possible to the original purposes of the trust.

Take note that within one month after the publication of this notice any person may make representations or suggestions to the Attorney General in respect of the proposed scheme.

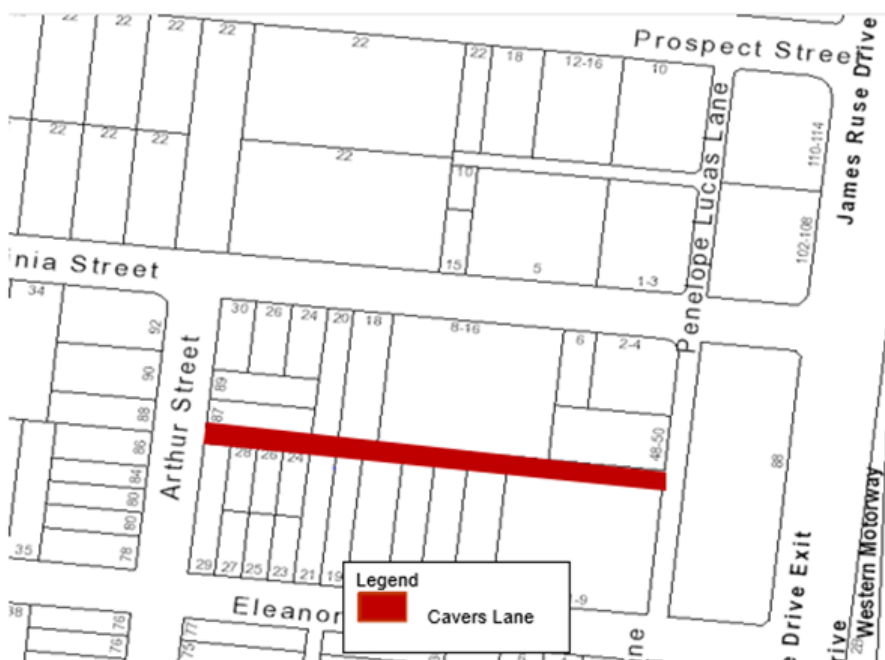
