ROAD TRANSPORT ACT 2013 - ORDER

The Honourable Margaret Beazley AO QC, Governor.

I, the Honourable Margaret Beazley AO QC, Governor of the State of New South Wales, with the advice of the Executive Council, and pursuant to the *Road Transport Act 2013* (the Act), do, by this Order, approve the type of traffic enforcement device named in Schedule 1 as being designed for the following uses:

- 1. **excess speed measurement**, designed to measuring the speed at which a vehicle is travelling in accordance with the terms of section 134(1)(a) of the Act;
- 2. **excess speed imaging**, designed to photograph a vehicle that is driven in excess of a speed limit applicable to a length of road in accordance with the terms of section 134(1)(b) of the Act;
- 3. **average speed imaging**, designed to photograph a vehicle at a point during its journey between different points on a road for use in calculating the vehicle's average speed between those points, in accordance with the terms of section 134(1)(c) of the Act;

Schedule 1 – Type of device:

The multiple use device, Redflex OTL Radar.
