### MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:

(a) DECLARE the following premises of **Inverell Hospital** to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:

• The Emergency Department of Inverell Hospital, located on Swanbrook Road, Inverell NSW 2360; and

# (b) DECLARE this facility to be designated as a "**mental health emergency** assessment (temporary emergency response)" facility; and

(c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the Mental Health Act 2007, with the exception of:

- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3; and

(d) IMPOSE the following condition in relation to the operation of the facility as a mental health facility:

i. Unless it is earlier revoked, this declaration expires on 26 March 2021.
