#### 1. Name of Notice

This Notice is the *Other criteria specified by regulator in respect of the quarry manager statutory function for Tier-2 quarries 2020*.

#### 2. Commencement and expiry

In this Notice:

- (a) Schedule 1 commences on the day the notice is published in the NSW Government Gazette and expires on 30 September 2022, and
- (b) Schedule 2 commences on 1 October 2022 and has effect until revoked.

#### 3. Interpretation

In this Notice:

*other criteria* means the criteria specified at item 5 below in accordance with clause 139(2)(b) of the Regulation.

*quarry manager practising certificate* means a certificate issued by the regulator enabling a person to exercise the statutory function of a quarry manager as specified in clause 31 Schedule 10 of the Regulation.

*risk profiling tool* means the tool used by the regulator to assess the hazards and complexity of a specified mine.

*Tier-2 quarry* means a mine determined by the regulator using the risk profiling tool to be a Tier-2 quarry.

*the Regulation* means the *Work Health and Safety (Mines and Petroleum Sites) Regulation 2014*.

Terms used in this Notice have the same meaning as in the *Work Health and Safety Act 2011*, *Work Health and Safety Regulation 2017*, *Work Health and Safety (Mines and Petroleum Sites) Act 2013* and the Regulation.

**Explanatory note:** An individual who is granted a quarry manager practising certificate in accordance with this Notice is not eligible to exercise the statutory function of quarry manager at a mine determined by the regulator, using the risk profiling tool, to be a Tier-1 quarry. The regulator may be satisfied that the individual is competent

to exercise the statutory function of quarry manager at a Tier-1 mine only if the individual holds a certificate of competence in respect of the statutory function. Nothing in this notice prevents the holder of a quarry manager practising certificate applicable to a Tier-1 quarry from exercising the functions of a quarry manager at a Tier-2 quarry.

#### 4. Revocation

The *Notice Other criteria specified by regulator in respect of quarry manager statutory function* dated 22 May 2017 and published in the NSW Government Gazette No 57 of 2 June 2017 is revoked on the date this Notice is published in the NSW Government Gazette.

#### 5. Other criteria

The criteria specified in Schedules 1 and 2 below is other criteria in respect of the statutory function of quarry manager listed in clause 31 of Schedule 10 of the Regulation.

The regulator may be satisfied that an individual is competent to exercise the statutory function of quarry manager in respect of a Tier-2 quarry, and be granted a practising certificate, if the individual meets the criteria in Column B or Column C in Schedule 1 (before 1 October 2022) or Schedule 2 (on and after 1 October 2022).

The practising certificate may be granted subject to the condition it is applicable only to a specified mine, or mines, that is a Tier-2 quarry or to all Tier-2 quarries. A practising certificate granted to an individual who meets the criteria in Column B of Schedule 1 may be subject to the condition the holder attains the qualification criteria in Column C of Schedule 1 before 1 October 2024.

If an application for a quarry manager practising certificate for a Tier-2 quarry in accordance with clause 140 of the Regulation to which the other criteria specified in Schedule 1 applies, is made before the commencement of Schedule 2 in this Order, and the application has not been finally determined before that commencement, the application is to be determined as if Schedule 2 had not commenced.

**WORK HEALTH AND SAFETY REGULATION 2017****WORK HEALTH AND SAFETY (MINES AND PETROLEUM SITES) EXEMPTION (USE OF CABLES IN HAZARDOUS ZONES) 2020**

under the Work Health and Safety Regulation 2017

I, Garvin Burns, Chief Inspector, having delegated authority from the Secretary of the Department of Regional New South Wales as the Regulator under the *Work Health and Safety Act 2011* in relation to a mine or petroleum site, pursuant to clause 684 of the *Work Health and Safety Regulation 2017*, grant the following class exemption.

**1 Name**

This Exemption is the *Work Health and Safety (Mines and Petroleum Sites) Exemption (Use of Cables in Hazardous Zones) 2020*.

## 2 Commencement

This Exemption commences on the date of publication in the NSW Government Gazette and has effect until cancelled.

## 3. Cancellation

This Exemption cancels the *Work Health and Safety (Mines and Petroleum Sites) Exemption (Use of Cables in Hazardous Zones) 2019* published in the NSW Government Gazette on 29 March 2019. That Exemption is cancelled and is replaced by this Exemption which clarifies that the exemption from compliance with clause 80(3)(b) and (c) of the Regulation does not apply where the design of an engineered system specified the use of compliant cables and the installed cables are identified as non-compliant with clause 80(3)(b) or (c) of the Regulation after the engineered system has entered service.

## 4 Interpretation

In this Exemption:

**engineered system** means a combination of items of plant and cables that is designed to work together to perform a specific function safely.

**compliant cable** means a cable that conforms to the requirements of clause 80(3)(b) or (c) of the Regulation.

**exempted cable** means a cable that does not conform to the requirements of clause 80(3)(b) or (c) of the Regulation and is intended to be used in an engineered system where conformance with these clauses is required.

**the Regulation** means the *Work Health and Safety (Mines and Petroleum Sites) Regulation 2014*.

Terms used in this Exemption have the same meaning as in the *Work Health and Safety Act 2011*, *Work Health and Safety Regulation 2017*, *Work Health and Safety (Mines and Petroleum Sites) Act 2013* and the Regulation.

## 5 Exemption

This Exemption is a class exemption made by the regulator on its own initiative.

This Exemption applies to the use of cables in a hazardous zone in an underground coal mine, where the concentration of methane in the general body of air is less than 1.25% by volume.

A mine operator of an underground coal mine is exempt from the requirements of clause 80(3)(b) and (c) of the Regulation, subject to the conditions specified in clause 6 of this Exemption.

This Exemption does not apply where the design of the engineered system specified the use of compliant cables and the installed cables are identified as non-compliant with clause 80(3)(b) or (c) of the Regulation after the engineered system has entered service.

## 6 Conditions

- (1) An exempted cable may only be used in a hazardous zone at the mine if the cable has been designed for use with an engineered system and it is used only as a component of that engineered system.
- (2) The individual nominated to exercise the statutory function of electrical engineering manager at the mine must determine that the use of an exempted cable in an engineered system will result in a standard of safety that is at least equivalent to the standard that would be achieved by compliance with clause 80(3)(b) and (c) of the Regulation.
- (3) The mine operator must keep all records relating to the determination in clause 6(2), including all risk assessments, engineering calculations and other relevant information while the engineered system is in use at the mine.

## 7 Exemption does not affect other requirements

Nothing in this Exemption affects any other applicable requirement imposed by law in relation to the matters this Exemption applies to.

**1. Name of Notice**

This Notice is the *Notice pursuant to Practising Certificate 2020 (Maintenance of Competency)*.

**2. Commencement**

This Notice commences on the date it is published in the NSW Government Gazette and has effect until it is revoked.

**3. Revocation**

The *Notice pursuant to Practising Certificate 2019 (Maintenance of Competency)* published in the NSW Government Gazette No 67 of 28 June 2019 at pages 2315 to 2478 is revoked on the date of commencement of this notice.

**4. Interpretation**

In this Notice:

*conditions* mean the conditions specified at item 6 below in accordance with clause 143 of the Regulation.

*formal learning* means organised and structured learning with specific learning objectives as referred to Table 3 of Schedule 1 and meets the criteria in schedule 1.

*holder* means a person who holds a practising certificate to exercise a statutory function.

*informal learning* means learning as a by-product of experience in participating or carrying out an activity as referred to in Table 3 of Schedule 1 as informal learning.

*learning hours* means the number of hours spent undertaking formal or informal learning.

*practising certificate* means a certificate issued by the regulator under clause 141 of the Regulation enabling a person to exercise a statutory function as specified in Schedule 10 of the Regulation.

*recognised learning types* mean the types of learning specified in Schedule 1.

*the Regulation* means the Work Health and Safety (Mines and Petroleum Sites) Regulation 2014.

*risk profiling tool* means the tool used by the regulator to assess the hazards and complexity of a specified mine.

*Tier-2 quarry* means a mine determined by the regulator using the risk profiling tool to be a Tier-2 quarry.

Terms used in this Notice have the same meaning as in the *Work Health and Safety Act 2011*, *Work Health and Safety Regulation 2017*, *Work Health and Safety (Mines and Petroleum Sites) Act 2013* and the *Work Health and Safety (Mines and Petroleum Sites) Regulation 2014*.

## 5. Exemption

Holders of practising certificates issued under the *Regulation* with a condition restricting them to practise at a specified mine or mines for Mines other than underground mines or coal mines, or Underground mines other than coal mines or any Teir-2 quarry are not required to comply with the requirements in this notice.

## 6. Conditions

The conditions specified in Schedule 1 below are the conditions which apply practicing certificates which contain a maintenance of competency condition that requires compliance with requirements published by the regulator in the NSW Government Gazette.

## **Criteria for types of learning**

### **Formal training courses**

In order to be eligible to claim formal learning hours from undertaking a formal training course, the holder must obtain from the training provider evidence that the course meets the following criteria:

- The course content, with or without learning objectives are documented, current and relevant to the holder's statutory function,
- The length of the course, including start and finish times are documented.
- The person(s) delivering or designing the course (including face to face, online or correspondence courses) has appropriate technical and/or educational ability, experience and qualifications relevant to the course.

The above evidence obtained by the holder should be retained in either in the holder's logbook or in separate documentation.

### **Tertiary qualifications**

Tertiary qualifications refer to any post school qualification recognised under the Australian Qualifications Framework (AQF).

If the holder is completing a tertiary qualification, they can claim study from a course that is relevant to WHS and the statutory function(s) on their practising certificate, such as:

- face to face, electronic or other form of direct interaction between the holder and the training institution
- completing required assessments either individually or as a group that involve studying and application of learning
- required reading of information or attending field excursions for the qualification.

### **Mutual recognition practising certificates**

If a holder has a NSW practising certificate in recognition of their interstate or New Zealand certificate of competence, the holder must comply with the requirements for the maintenance of competency scheme as part of the condition on their NSW Practising certificate.
