# ENVIRONMENTAL PLANNING AND ASSESSMENT (COVID-19 DEVELOPMENT—VEHICLE SANITISATION STATIONS) ORDER 2020

I, the Hon. Rob Stokes, MP, the Minister for Planning and Public Spaces, make the following Order under section 10.17 of the *Environmental Planning and Assessment Act 1979*.

I am satisfied this Order is necessary to protect the health, safety and welfare of members of the public during the COVID-19 pandemic as it facilitates the use of certain buildings or places as vehicle sanitisation stations to help mitigate against the potential spread of COVID-19. I have consulted with the Minister for Health and Medical Research in relation to the making of this Order.

#### 1 Name of Order

This Order is the Environmental Planning and Assessment (COVID-19 Development—Vehicle Sanitisation Stations) Order 2020.

#### 2 Commencement

This Order commences on the day it is published in the Gazette and remains in force for the prescribed period.

#### 3 Definitions

(1) In this Order—

prescribed period has the meaning that it has in section 10.17 of the Act,

the Act means the Environmental Planning and Assessment Act 1979.

**Note.** The Act and the *Interpretation Act 1987* contain definitions and other provisions that affect the interpretation and application of this Order.

- (2) A word or expression used in this Order has the same meaning as it has in the Standard Instrument set out in the Standard Instrument (Local Environmental Plans) Order 2006.
- (3) Notes included in this Order do not form part of this Order.

# 4 Relationship with orders under the *Public Health Act 2010*

To the extent that this Order is inconsistent with an order under Part 2 of the *Public Health Act 2010*, the order under that Part prevails.

#### 5 Development authorised by this Order

The development specified for this Order may be carried out without the need for any approval under the Act if it complies with the conditions specified for the development.

### 6 Vehicle sanitisation stations — use and temporary works

- (1) The use of a building or place as a vehicle sanitisation station is development specified for this Order.
- (2) The construction or installation of a temporary structure, and a temporary alteration or addition to a building or work for a purpose described in subclause (1) is development specified for this Order.
- (3) The conditions specified for the development are that the development must—
  - (a) be carried out:
    - (a) on land that can lawfully be used for the purpose of industry or a vehicle repair station, or
    - (b) in an existing warehouse or distribution centre, and
  - (b) be carried out by or on behalf of Transport for NSW, and
  - (c) have the consent in writing of the owner of the land unless the owner is Transport for NSW, and
  - (d) if the development is carried out on land that is the subject of an existing development consent— be carried out in accordance with all conditions of the consent other than a condition that:
    - (a) restricts the hours of work or operation,
    - (b) restricts the frequency or movement of vehicles,
    - (c) restricts the layout or location of development,
    - (d) relates to noise, or

- (e) requires anything to be done before a building is occupied, and
- (e) only be carried out between 7am and 7pm, and
- (f) incorporate measures to:
  - (a) reduce noise, and
  - (b) ensure the use does not unreasonably interfere with the quiet enjoyment of neighbouring properties, and
- (g) in the case of the temporary alteration or addition to a building or work—not remain in place for more than 4 months after the expiry of prescribed period.
- (4) In this clause—

# vehicle sanitisation station means a building or place used for the purpose of sanitising:

- (a) an emergency services vehicle with the meaning of the *Road Transport (Vehicle Registration)* Regulation 2017,
- (b) fleet vehicles used by staff employed by:
  - i. the Government of NSW in the Transport Service,
  - ii. the Government of NSW in the Public Service,
  - iii. Sydney Trains, or
  - iv. NSW Trains,
- (c) taxis and hire vehicles within the meaning of the Point to Point Transport (Taxis and Hire Vehicles) Act 2016, and
- (d) vehicles used for community transport services within the meaning of the *Passenger Transport Act* 2014.

# Practice Note DC (Civil) No. 7

# **Court Approval of Settlements**

This Practice Note revises the version published on 6 May 2009 and commences on 31 August 2020.

This Practice Note only applies to actions commenced in the Sydney Registry of the Court or matters transferred to Sydney for the purpose of approval.

- 1. Approval of settlements will be determined in Chambers, unless otherwise notified by the Court.
- 2. A matter will be considered for approval upon the filing in the Registry of the following documents (together the "Approval Documents"):
  - (a) A Written Request for Approval (for proceedings already commenced) or Summons (where proceedings have not been commenced);
  - (b) any affidavits to be relied upon for the proper consideration of the approval;
  - (c) the signed Judgment Order reflecting the settlement agreed on by the parties;
  - (d) a Confidential Advice in a sealed envelope from the most senior legal representative acting for the plaintiff as to whether and why the settlement should be approved. This advice (which should not be filed or shown to the opposing party without express instructions to that effect) should analyse any issues regarding liability, the extent of any discount for liability and provide an itemised assessment of the damages by reference to the medical evidence exchanged between the parties. Where the plaintiff is not a minor, the Confidential Advice should indicate that consideration has been given to the impact of the settlement on the plaintiff's other financial arrangements and entitlements;
  - (e) if necessary, an undertaking of the type referred to in paragraph 7 below; and
  - (f) a draft in electronic form and Word format of the Orders proposed to be entered onto JusticeLink, which may be attached to the

affidavit of the solicitor for the plaintiff together with the Consent Judgment entered into inter parties.

A return date will not be allocated by the Registry but the Approval Documents will be referred to the Approvals Judge for attention.

- 3. For proceedings which have been listed for hearing, the Approval Documents, with the exception of the Confidential Advice which is to remain sealed, must be filed as soon as possible after the settlement has been reached and in any event by no later than 4pm on the day preceding the first day set for hearing. In all matters with a hearing date, the parties must be prepared to proceed with the hearing on the day set in the event that the settlement is not approved. Hearing dates will not be vacated until or unless the settlement is approved.
- 4. A matter should not be submitted for approval unless the application is ready to proceed. If the plaintiff's disability requires orders to be made by the Supreme Court or Guardianship Board, application for those orders should, where possible, be made prior to the filing of the Approval Documents and the affidavit material should attach copies of the court documents and/or orders.
- 5. If the Court directs that the matter be listed in Court for approval, the plaintiff and the tutor will not be required to attend at the hearing of the application, unless otherwise ordered by the Presiding Judge. If the reasons for listing the matter for approval are that incomplete documentation has been provided, an affidavit of explanation from the solicitor with conduct of the matter should be provided to the Presiding Judge and such conduct may be the subject of costs orders, including personal costs orders.
- 6. The affidavit evidence must include the following information and documents:
  - (a) whether the settlement reflects a compromise on liability and, if so, copies of all relevant documents to permit the Court to make an assessment of liability;
  - (b) up to date medical evidence dealing with all relevant medical issues, including diagnosis, prognosis, the need for treatment or domestic assistance and the medical basis for any claim for economic loss;
  - (c) if the plaintiff claims damages as a result of any scarring or other visible deformity, recent colour photographs depicting same. The photographs should bear the date upon which they were taken;

- (d) evidence from the tutor in respect of the following matters:
  - (i) the plaintiff's current disabilities, if any;
  - (ii) any expenses incurred by the tutor in respect of which reimbursement is sought;
  - (iii) acknowledgment by the tutor that the settlement is final and that the plaintiff will have no further rights against the defendant(s);
  - (iv) acknowledgement by the tutor of the net sum to be invested for the plaintiff and where that sum is to be invested;
  - (v) confirmation from the tutor that the amount allowed for past-out-of-pocket expenses in the settlement includes all accounts, both paid and unpaid, of which the tutor is aware having made all relevant enquires.
  - (vi) details of the past out-of-pocket expenses both paid and unpaid, including a current Notice of Charge from Medicare and the specific amount (if any) to be repaid to the defendant(s) for reimbursement;
  - (vii) details of any other deductions to be made from the settlement, for example to Centrelink;
  - (viii) confirmation by the solicitor for the plaintiff that costs and disbursements on a party/party basis will be accepted in full satisfaction. In the event that is not the case, then the solicitor must explain why and specify the amount to come out of the settlement for solicitor/client costs. Unless orders are made to the contrary by the Presiding Judge, the allowance of any such costs will be at the discretion of NSW Trustee and Guardian or any other trustee managing the plaintiff's affairs.
- 7. In cases where an undertaking is required from a legal representative in relation to either the payment of out of pocket expenses or the reimbursement of payments made, the undertaking should, unless the court otherwise orders, be in the following form:

# **Undertaking**

### District Court Criminal Practice Note 20

# **Sentence Matters**

1. This Practice Note revises and consolidates District Court Criminal Practice Notes 1 and 15.

### Commencement

2. This Practice Note commences on 31 August 2020.

# **Application**

3. This Practice Note applies to all proceedings committed to the District Court for sentence on or after the commencement date.

### **Definitions**

4. In this Practice Note:

"court" means the District Court of New South Wales

"Crown Sentence Bundle" includes the Crown Coversheet, statement of facts, and evidentiary material in the Crown case

"offender" includes an Australian legal practitioner representing an offender

"service" of documents required under this Practice Note may be effected by service on the legal representatives for an offender or by service personally on an offender who is not legally represented.

# Listing for entering a plea

5. When committing an offender to the court at Sydney for sentence, the magistrate will direct the person to appear for arraignment on the last sitting day of the week (usually a Friday) four weeks after the date of the committal.

Page 1 of 4

- 6. A similar procedure is to apply to all other District Court venues but the arraignment day will vary from venue to venue. Practitioners should ascertain the relevant day which is nominated by the list judge or resident judge.
- 7. The magistrate may order a sentencing assessment report where appropriate. Practitioners should address this issue in the Local Court where possible as this allows the report to be prepared at an earlier date.

# **Entering a plea**

- 8. The offender must be present on the day fixed for the arraignment either in person or by way of audio visual link.
- 9. Upon presentment of the indictment or charge certificate, the offender will be arraigned by the court and shall enter his or her plea.
- 10. If there is a traversal of plea at any stage of the proceedings, the provisions of Practice Note 18 are to apply.

# Listing for sentence

- 11. Upon a guilty plea being entered to some or all of the charges on the indictment and a signed statement of agreed facts being tendered, the matter will be listed for sentence hearing. The matter will not be listed for sentence hearing without a signed statement of agreed facts.
- 12. If the facts are not agreed, the matter will be listed for further mention in three weeks and, unless the court otherwise orders, the standard directions that are to apply are:
  - (a) The prosecution is to serve on the offender, within one week, a statement of proposed facts;
  - (b) The offender is to serve on the prosecution, within one week of receiving the statement of proposed facts, a response noting areas of dispute and a list of any witnesses required for cross examination; and
  - (c) The prosecution is to serve on the offender, within one week of receiving the response, a final version of proposed facts and witness availability.

At the subsequent mention the matter will be listed for sentence hearing. The disputed facts will be determined in the single hearing, unless the court otherwise orders.

- 13. When the matter is listed for sentence hearing, the prosecutor and the legal representatives for the offender are to provide the court with:
  - (a) an accurate estimate of the length of the sentencing hearing as well as the dates suitable for the parties to appear;
  - (b) any requirement for a sentencing assessment report;
  - (c) the address of the nearest corrective services office to the offender; and
  - (d) any requirement for interpreters, including the language and number.
- 14. The prosecution and the offender are to file their notice of appearance including the name, email and telephone contact of the practitioner appearing at the sentence hearing by emailing <a href="mailto:ag-sdc-crime@justice.nsw.qov.au">ag-sdc-crime@justice.nsw.qov.au</a> for Sydney matters or to the registry of the District Court venue that matter is being heard at, no later than five days prior to the arraignment date.

### Standard directions

- 15. Unless the court otherwise orders, the standard directions that are to apply at the arraignment are:
  - (a) The prosecution is to file and serve the Crown Sentence Bundle no later than two weeks prior to the sentence date.
  - (b) The offender is to file and serve any documentary material, including expert reports, to be relied upon on at sentence no later than seven days prior to the sentence date.
  - (c) The prosecution and the offender are to file and serve any further documents they rely on and an outline of submissions no later than three days prior to the sentence date.

### Sentence

16. By the date fixed for the sentence hearing, the matter must be ready to proceed. If there is an unavoidable problem or change to the conduct or the length of the sentence hearing, the parties are to notify at the earliest possible stage the list judge or resident judge at venues other than Sydney, and for Sydney sentences the Criminal Listing Director.

# Non-compliance with the court's directions

- 17. If it appears to the court that a party has not complied with this Practice Note or with any other direction made by the court, the court may contact the offending party directly or list the matter for mention, either on the court's own initiative or at the request of either party.
- 18. Without limiting the court's power otherwise to deal with a failure to comply with a direction, the court may order the offending party to file an affidavit, or give evidence in court, explaining the failure to comply.
