LOCAL GOVERNMENT ACT 1993 ORDER UNDER SECTIONS 438M and 4380

By Order published in the New South Wales Government Gazette on 12 June 2020 I, the Hon Shelley Hancock MP, Minister for Local Government, suspended Armidale Regional Council for a period of three months.

The Order is due to expire on 12 September 2020.

By this Order, I extend the period that Armidale Regional Council is suspended by the Order that commenced on 12 June 2020 for a further period of three months.

The extension to the 12 June 2020 Order commences at the expiration of that Order and finishes on 11 December 2020.

By this Order, I hereby re-appoint Mr VHR (Viv) May PSM as Interim Administrator of the Council for the period during which Council is suspended by this Order.

This Order takes effect upon publication in the New South Wales Government Gazette.
