## **REGULATION OF VESSELS – EXCLUSION ZONE**

## Location

Hawkesbury River, Windsor Reach – the entire width of the river between Windsor Bridge and the furthest downstream end of Windsor Reach.

## Duration

9:00am to 5:00pm on each of the following Sundays during 2020 and 2021:

- 20 September 2020
- 11 October 2020
- 18 October 2020
- 8 November 2020
- 8 December 2020
- 7 February 2021
- 7 March 2021
- 11 April 2021
- 2 May 2021
- 11 July 2021
- 8 August 2021

## Detail

Competitive power boat races will be conducted on the navigable waters of the Hawkesbury River at the location specified above, involving the use of high speed power vessels racing at speed, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be marked by the presence of control vessels stationed on the perimeter.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998)
