It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of Her Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 22 — An Act to amend the Adoption Act 2000 and the Births, Deaths and Marriages Registration Act 1995 to introduce integrated birth certificates for adopted persons and allow access to integrated birth certificates to adopted persons and other persons; and for other purposes. [Adoption Legislation Amendment (Integrated Birth Certificates) Bill]

Act No. 23 — An Act to amend the Police Act 1990 and the Police Regulation 2015 with respect to the promotions process for non-executive police officers to the ranks of sergeant, inspector and superintendent; and for other purposes. [Police Amendment (Promotions) Bill]

Act No. 24 — An Act to amend various Acts and regulations relating to courts and to other Communities and Justice portfolio matters. [Stronger Communities Legislation Amendment (Courts and Civil) Bill]

Act No. 25 — An Act to amend various Acts and Regulations administered by the Minister for Better Regulation and Innovation; and for related purposes. **[Better Regulation Legislation Amendment Bill]**

Act No. 26 — An Act to amend various Acts relating to crimes and other matters in the Communities and Justice portfolio. [Stronger Communities Legislation Amendment (Crimes) Bill]
