PROTECTION OF THE ENVIRONMENT OPERATIONS (WASTE) REGULATION 2014

Notice to vary notice under Clause 21A: Variation of notice of approved scheduled waste facilities and other requirements for levy exempt mixed waste organic outputs

I, Richard Bean, Chief Executive Officer of the Environment Protection Authority (EPA), on behalf of the EPA, by this notice vary the notice under clause 21A of the *Protection of the Environment Operations (Waste) Regulation 2014* (Waste Regulation) on page 8048 of Government Gazette No 114 of 2 November 2018, as varied by the notice on page 4131 of Government Gazette No 109 of 20 September 2019 and as further varied by the notice on pages 4672 and 4673 of Government Gazette No 130 of 1 November 2019 (the Notice) by:

1. deleting clause 1.1 of the Notice; and
2. deleting the table in the Notice and replacing it with the following table:
