# MENTAL HEALTH ACT 2007 Section 109 Declaration of mental health facility

- I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and to, in part, facilitate the transfer of patients from a current declared mental health facility situated at Bridge Road, West Campus of Cumberland Hospital, to alternate accommodation on Gardens Way, West Campus of Cumberland Hospital, **DO HEREBY**:
- (a) **REVOKE** the Order published in the NSW Government Gazette No. 126 of 24 November 2017, declaring certain premises of Cumberland Hospital, Westmead, to be a declared mental health facility for the purposes of section 109 of the Mental Health Act 2007; and
- (b) **DECLARE** the following premises to be a declared mental health facility for the purposes of section 109 the *Mental Health Act 2007*:

Cumberland Hospital West Campus, 1-11 Hainsworth Street, Westmead NSW 2145, comprising the following units:

- Acacia Unit, on Gardens Way
- Banksia Cottages Complex, on Hainsworth Street
- Old Boronia Unit, on Bridge Road (until 28 February 2021)
- Boronia Unit, on Gardens Way
- Hainsworth Unit, on Paringa Avenue
- Jarrah Cottages Complex, on Gardens Way
- Paringa Unit, on Paringa Avenue
- Riverview Unit, on Paringa Avenue
- Waratah Cottages Complex, on Hainsworth Street
- Willow Cottages Complex, on Gardens Way
- Yaralla Unit, on Paringa Avenue; and

Cumberland Hospital East Campus, 5 Fleet Street, North Parramatta NSW 2145, comprising the following units:

- Bunya Unit, on Bridge Road
- Red Gum Cottage, on New Street; and
- (c) DECLARE this facility to be designated as a "mental health assessment and inpatient treatment" facility.

### **Authority**

Pursuant to clause 171(1) of the Regulation, this authorisation is granted subject to conditions.

#### 1 Authorisation

This instrument authorises the supply of Schedule 2, Schedule 3 and Schedule 4 substances as listed in section 3 of this instrument by the authorised class of persons as listed in section 2.

#### 2 Authorised Class of Persons

A person who is employed or engaged as a Patient Transport Officer, Registered Paramedic or Registered Nurse by the Royal Flying Doctor Service Victoria.

### 4 Conditions

- a. The Schedule 2, Schedule 3 and Schedule 4 substances must be obtained from a licensed wholesaler.
- b. The Authorised Person must supply (including administer) the Schedule 2, Schedule 3 and Schedule 4 substances in accordance with the current Royal Flying Doctor Service Victoria, NSW Clinical Practice Protocols.

## 5 Validity

This authority commences on the day it is signed and dated, and expires on the date this authority is suspended, cancelled or surrendered.
