REGULATION OF VESSELS - EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Sydney Harbour - Farm Cove to North Head

Special event area

The event will take place within a special event area encompassing all navigable waters bounded by lines drawn between:

- · Bennelong Point Port Beacon and Kirribilli Point,
- The most northerly point of Middle Head and Cannae Point Flagstaff, and
- North Head Starboard Beacon and Hornby Light

Duration

12:00pm to 4:00pm – Tuesday 8 December 2020

Detail

CYCA Grinders Coffee SOLAS Big Boat Challenge 2020 event will take place in the special event area specified above.

Due to the potential of the event to affect the safety of navigation, the following **EXCLUSION ZONES** are specified during the event:

- 1. The area between two rows of yellow exclusion zone buoys laid to the North-West of Point Piper (the starting area) between 12:00pm and 12:50pm, and
- 2. The area extending 100m South-West of a line of yellow exclusion zone buoys laid to the North-West of Shark Island while the race yachts are in the immediate vicinity.

The limits of the exclusion zones are provided on the event map (see below) and will be marked by yellow buoys and the presence of patrol vessels.

Only competing vessels, authorised media vessels and official control vessels are permitted within the exclusion zones.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zones during the event.

Penalties may apply (section 12(5) - Marine Safety Act 1998).

Special restrictions on vessel operations

Pursuant to section 12(3) of the *Marine Safety Act 1998*, operators of all vessels navigating within 200 meters of an active exclusion zone must comply with the following special restrictions:

- Maintain a maximum speed limit of 6 knots, and
- Produce minimal wash.

Penalties may apply (section 12(5) - Marine Safety Act 1998).



Detail

A fireworks display will be conducted over the navigable waters of Lake Macquarie at the location specified above. Fireworks will be launched from a moored firing barge at the above location. The area directly around this firing position may be dangerous and hazardous to other waterway users while fireworks are being launched.

An **EXCLUSION ZONE** is specified during the event, extending 200 metres around the moored barge. This zone will be indicated by the presence of control vessels which will be stationed on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

A fireworks display will be conducted over the navigable waters of Lake Macquarie at the location specified above. Fireworks will be launched from a moored firing barge at the above location. The area directly around this firing position may be dangerous and hazardous to other waterway users while fireworks are being launched.

An **EXCLUSION ZONE** is specified during the event, extending 150 metres around the moored barge. This zone will be indicated by the presence of control vessels which will be stationed on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

Lake Albert, Wagga Wagga – all navigable waters

Duration

- 8:00am to 6:00pm Saturday 5 December 2020
- 8:00am to 6:00pm Sunday 6 December 2020

Detail

Powerboat demonstrations will be conducted on the navigable waters of Lake Albert, involving the use of high speed power vessels which will be active in the area during the above times.

Support vessels will be present to manage the event. Participating vessels will operate at high speed, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the entirety of Lake Albert, which will effectively close the Lake to all other vessel use between the above times for this event.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be patrolled by TfNSW Maritime officers.

An **EXCLUSION ZONE** is specified during the event, which will be marked by buoys at the above location.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be patrolled by control vessels.

Special Restrictions - Transit lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'. Pursuant to section 12(3) of the *Marine Safety Act 1998*, special restrictions are applicable to vessels using the transit lane:

- Maximum speed limit of 6 knots, and
- Minimal wash must be produced.
