The object of this Order is to amend the *Public Health (COVID-19 Northern Beaches) Order 2020* to include special provisions for 24, 25 and 26 December 2020.

## **Public Health (COVID-19 Northern Beaches) Amendment Order (No 2) 2020**

under the

Public Health Act 2010

### **1 Name of Order**

This Order is the *Public Health (COVID-19 Northern Beaches) Amendment Order (No 2) 2020*.

### **2 Commencement**

This Order commences at the end of 23 December 2020.

## Schedule 1 Amendment of Public Health (COVID-19 Northern Beaches) Order 2020

### [1] Part 4A

### Part 4A Special provisions for Christmas period

#### 10A Definitions

(1) In this Part—

*Christmas period* means the period from the beginning of 24 December 2020 to the end of 26 December 2020.

*Northern area* means the part of the Northern Beaches local government area shown as the Northern area on the Public Health (COVID-19 Northern Beaches) Map approved by the Minister from time to time.

**Note.** A copy of the map is available on the NSW Government website [www.nsw.gov.au](http://www.nsw.gov.au).

*Northern area resident* means a person whose current place of residence or temporary accommodation is in the Northern area.

*Southern area* means the part of the Northern Beaches local government area that is not in the Northern area.

*Southern area resident* means a person whose current place of residence or temporary accommodation is in the Southern area.

(2) For the purposes of this Part, a person is not a visitor to a place of residence if the person is a member of the household of the place of residence.

#### 10B Exceptions to clauses 7–9 during Christmas period

(1) Despite clause 7, a Northern area resident may, during the Christmas period, be away from the resident's place of residence or temporary accommodation for the purposes of a visit to a place of residence in the Northern area in accordance with clause 10C.

(2) Despite clause 7, a Southern area resident may, during the Christmas period, be away from the resident's place of residence or temporary accommodation for the purposes of a visit to a place of residence in the Southern area in accordance with clause 10D.

(3) Despite clause 8, a person may, during the Christmas period, enter the Southern area for the purposes of a visit to a place of residence in the Southern area in accordance with clause 10D.

(4) Despite clause 9, a person may, during the Christmas period, participate in an outdoor public gathering if the gathering is permitted under clause 10E.

#### 10C Directions of Minister about number of persons allowed on residential premises in Northern area

(1) The Minister directs that each adult member of a household of a place of residence in the Northern area must not allow more than 5 Northern area residents to visit the place of residence on any day during the Christmas period.

(2) The Minister directs that a Northern area resident who is visiting a place of residence in the Northern area must not, during the Christmas period,

participate in a gathering at the place of residence consisting of more than 5 visitors who are Northern area residents.

**10D Directions of Minister about number of persons allowed on residential premises in Southern area**

- (1) The Minister directs that each adult member of a household of a place of residence in the Southern area must not allow more than 10 visitors to visit the place of residence on any day during the Christmas period.
- (2) The Minister directs that a visitor to a place of residence in the Southern area must not, during the Christmas period, participate in a gathering at the place of residence consisting of more than 10 visitors.
- (3) A person aged 12 years or under is not to be counted as a visitor to a place of residence in the Southern area.

**10E Directions of Minister concerning gatherings in outdoor public places**

- (1) The Minister directs that a gathering that is permitted at a place of residence in the Northern area in accordance with clause 10C may take place at an outdoor public place in the Northern area instead of at the place of residence.
- (2) The Minister directs that a gathering that is permitted at a place of residence in the Southern area in accordance with clause 10D may take place at an outdoor public place in the Southern area instead of at the place of residence.

## Explanatory note

The object of this Order is to amend the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 7) 2020* to—

- (a) extend provisions due to expire at the end of 23 December 2020 that placed additional restrictions on the number of people permitted at residential premises, holiday homes and short-term rentals in Greater Sydney, and
- (b) make special provisions for the number of people permitted at residential premises, holiday homes and short-term rentals in Greater Sydney during 24–26 December 2020.

### **1 Name of Order**

This Order is the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 7) Amendment Order (No 3) 2020*.

### **2 Commencement**

This Order commences at the end of 23 December 2020.

## **Schedule 1      Amendment of Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 7) 2020**

**[1]    Clause 15 Directions of Minister about number of persons allowed on residential premises**

Omit “From the beginning of 21 December 2020 until the end of 23 December 2020 for” from clause 15(5).

Insert instead “For”.

**[2]    Clause 15(6)–(8)**

Insert after clause 15(5)—

(6)    The Minister directs that each adult member of a household of a place of residence in Greater Sydney must not allow more than 10 visitors to visit the place of residence on any day during the Christmas period.

(7)    A person aged 12 years or under is not to be counted as a visitor to a place of residence in Greater Sydney during the Christmas period.

(8)    In this clause—

*Christmas period* means the period from the beginning of 24 December 2020 to the end of 26 December 2020.

*place of residence* includes a holiday home or short-term rental.

**[3]    Clause 31 Direction of Minister about holiday homes and short-term rentals**

Omit “From the beginning of 21 December 2020 until the end of 23 December 2020 for” from clause 31(2).

Insert instead “For”.

**[4]    Clause 31(2A)**

Insert after clause 31(2)—

(2A)    From the beginning of 24 December 2020 until the end of 26 December 2020, a person aged 12 years or under is not to be counted for the purposes of this clause if the premises are in Greater Sydney.
