## STATE OWNED CORPORATIONS ACT 1989

Direction to the Board of Essential Energy

Notice of Reasons for Giving the Direction

I, the Minister for Energy and Environment, with the approval of Treasurer, issued a Direction under section 20P of the *State Owned Corporations Act 1989* to Essential Energy on 28 February 2020 ('the Direction').

The reasons for the Direction being issued are:

- The impacts of the current NSW drought provide sufficient grounds for making a case for exceptional circumstances, given over 98 per cent of NSW is in drought or recovering from drought with Level 1 to 5 water restrictions in place, the drought is significantly worse than the Millennium Drought, and the Bureau of Meteorology describes the conditions for the Murray Darling Basin as the worst on record:
- The drought is negatively impacting the number of forecast jobs in regional NSW, including beyond the agricultural sector, with flow-on effects to all parts of the economy including the retail trade, road transport, food manufacturing and construction sectors.
- Issuing the direction is in the public interest, in my view, as it will ensure jobs are retained in regional areas, supporting spending in local economies that are being impacted by the current drought.

This notice is published under sections 20P(5) and (6) of the State Owned Corporations Act 1989.

#### REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

#### Location

Richmond River, Coraki to Woodburn – between the Coraki Boat Ramp (at the confluence of the Richmond and Wilson's River) rounding at a location 2 km upstream of Court Street, Woodburn.

#### **Duration**

7:30am to 4:30pm - Saturday 7 March 2020 and Sunday 8 March 2020.

#### **Detail**

Competitive water ski races will be conducted on the navigable waters of the Richmond River as specified above involving the use of high speed power vessels, persons being towed at speed using tow-lines and persons in the water.

An **EXCLUSION ZONE** is specified during the event at the location above and will be indicated by the presence of buoys and patrolled by Maritime and Police vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

#### Transit lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'.

**SPECIAL RESTRICTIONS** apply to vessels using the transit lane. Pursuant to section 12(3) of the Act, vessels navigating through the transit lane must do so at a speed not exceeding 4 knots and must produce no wash.

# 1. Name of Exemption

This Exemption is the Work Health and Safety Regulation 2017, Exemption No.000/20.

# 2. Commencement

This Exemption commences on 26 February 2020 and has effect until 26 February 2025, unless otherwise varied or cancelled.

#### 3. Definitions

In this Exemption:

Act means the Work Health and Safety Act 2011.

*Ferro-Nickel slag* means—material containing chromium (III) compounds at no more than 0.8% used for abrasive blasting.

*Ferro-Nickel slag PCBU* a person controlling a business or undertaking that uses, handles or stores, or directs or allows a worker at the workplace to use, handle or store *Ferro-Nickel slag*.

Regulation means the Work Health and Safety Regulation 2017.

Words used in this Exemption have the same meaning as the Act and Regulation.

#### 4. Exemption

This Exemption is a class exemption made by SafeWork NSW on its own initiative following an application from SLN Australia Pty Ltd.

This Exemption applies to a Ferro-Nickle slag PCBU.

Subject to the conditions contained in Schedule 1, a Ferro-Nickle slag PCBU is exempted from the requirement in clause 382(1) and Item 8, Table 10.3, Schedule 10 of the Regulation, that a person conducting a business or undertaking at a workplace must not use, handle or store, or direct or allow a worker at the workplace to use, handle or store, Ferro-Nickle slag containing chromium (III) compounds for abrasive blasting at a concentration of greater than 0.5% (except as specified for wet blasting) as chromium.

#### **SCHEDULE 1**

This Exemption is subject to the following conditions:

- 1. *Ferro-Nickel slag PCBU's* must ensure Ferro-Nickle slag containing chromium (III) compounds for abrasive blasting contain no more than 0.8% chromium (III) and no other chromium compounds.
- 2. Ferro-Nickel slag PCBU's to which this exemption applies must ensure health monitoring is provided to a worker carrying out work for the business or undertaking in accordance with clause 368 of Regulation 2017 as if there was a significant risk to the worker's health because of exposure to Ferro-Nickle slag containing chromium (III) compounds at a concentration of greater than 0.5% chromium under clause 368(a) or a significant risk that the worker will be exposed under clause 368(b).
- 3. A Ferro-Nickel slag PCBU that is a manufacturer or importer of Ferro-nickel slag materials must determine and classify the hazardous chemicals present in the slag in accordance with clause 329 of the Regulation and prepare and provide safety data sheets (SDS) for the Ferro-Nickel slag materials in accordance with clause 330 of the Regulation. A copy of this exemption must be included as an attachment to the SDS. The SDS must include information in relation to:

- a) the steps that will be taken to monitor the health of workers as required by condition 2 to this Exemption.
- b) the waste disposal methods that must be used. These waste disposal methods must comply with all regulatory requirements of New South Wales including requirements relating to environmental hazards and waste disposal protocols that are required to be followed.
- 4. *A Ferro-Nickel slag PCBU that is a manufacturer or importer of Ferro nickel slag materials* must ensure the *Ferro-Nickel slag* materials are correctly labelled in accordance with clause 335 of the Regulation. The label must include information in relation to the steps that will be taken to monitor the health of workers as required by condition 2 to this Exemption.
- 5. *Ferro-Nickel slag PCBU's to which this exemption applies* must comply with all other requirements imposed by the Regulation.
- 6. *Ferro-Nickel slag PCBU's* must ensure that abrasive blasting is conducted in an enclosed area so far as is reasonably practicable.
- 7. *Ferro-Nickel slag PCBU's* must comply with all requirements of the Code of Practice on Abrasive blasting approved under section 274 of the Act.
- 8. **Ferro-Nickel PCBU's** must ensure that workers wear Powered Air Purifying Respirators (PAPR) while using the **Ferro-Nickel slag** as abrasive blasting material. For further information see: AS/NZS 1716–2012: Respiratory protective devices and AS/NZS 1715–2009: Selection, use and maintenance of respiratory protective equipment


