- (1) The possession limit in this order applies to any person in any waters.
- (2) Notwithstanding Table 1 in clause 6 of the Regulation, a possession limit of zero is imposed for Blue Swimmer Crabs (*Portunus armatus*) with a measurement of less than 6.5 cm.

yabby trap means a trap designed for taking yabbies that complies with the description in the table to clause 41 of the Regulation.
