REGULATION OF VESSELS – SPECIAL RESTRICTIONS

Location

Murray River – near the township of Torrumbarry between the 1638km and 1648km river markers.

Duration

- 7:00am to 6:00pm Saturday 27 March 2021
- 7:30am to 11:00am Sunday 28 March 2021

Detail

A fishing competition will be conducted on the navigable waters of the Murray River as specified above.

Due to the risk to safe navigation as a result of the large number of participating vessels, a Regulated Area with special restrictions is specified for the full width of the Murray River between the locations detailed above.

The Regulated Area will be marked and monitored by control vessels stationed at the perimeter and at various stages along the River.

Special Restrictions

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, special restrictions are in place in the Regulated Area between the above times:

• **No aquaplaning or towing** (including water skiing, wakeboarding, and tube riding) is permitted in the Regulated Area.

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Macquarie River, Dubbo – between Tamworth Street Footbridge and Erskine Street Bridge at the following locations:

- From the bottom of the Ollie Robins Boat Ramp to the western bank; and
- From Sandy Beach to the western bank of Sir Roden Cutler Park.

Duration

6:00am to 5:00pm – Saturday 27 March 2021

Detail

A number of river crossings will be conducted by participants in an endurance event on the navigable waters of Macquarie River at the location and times specified above. Participants will use floating ropes to assist them crossing the river at two locations during the event, presenting a potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of control vessels stationed on the border and flotation ropes and devices at each crossing.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be monitored and patrolled by control vessels.

Penalties may apply (Section 12(5) - Marine Safety Act 1998)

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Lake Albert, Wagga Wagga – all navigable waters.

Duration

- 8:00am to 6:00pm Saturday 20 March 2021
- 8:00am to 6:00pm Sunday 21 March 2021

Detail

Water Ski Races will be conducted on the navigable waters of Lake Albert, involving the use of high speed power vessels which will be active in the area at the location and times specified above.

Support vessels will be present to manage the event. Participating vessels and skiers will operate at high speed, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the entirety of Lake Albert, which will effectively close the Lake to all other vessel use between the above times for this event.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone, which will be monitored by event safety official vessels and Maritime officers.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

REGULATION OF VESSELS - EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Murray River – near Albury, between the Hume Weir Wall (downstream) to Noreuil Park.

Duration

- 2:00pm to 7:00pm Saturday 27 March 2021
- 9:00am to 2:00pm Sunday 28 March 2021

Detail

A canoe and kayak event will be conducted on the waters of the Murray River at the location specified above.

The Regulated Area will surround and move with the competing vessels over the length of the course.

An **EXCLUSION ZONE** is specified during the event which will be marked by the presence of control vessels.

Special Restrictions

Due to the risk to safe navigation and as a result of the nature and number of participating vessels, a Regulated Area will be created between the above times within which **Special Restrictions** are imposed. The Regulated Area will comprise the full width of the Murray River, and will extend 200 metres ahead and 200 metres to the stern of the competing vessels.

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, special restrictions are applicable to **powered vessels** operating in the Regulated Area:

- Maximum speed limit of 4 knots, and
- Minimal wash must be produced.

Penalties may apply (section 12(5) - Marine Safety Act 1998)
