#### **REGULATION OF VESSELS – EXCLUSION ZONE**

#### Location

Merewether Beach, Newcastle – between Merewether Surf Life Saving Club and Merewether Ocean Baths.

#### Duration

7:00am to 5:00pm on the following days:

• 1 to 11 April 2021 (inclusive - 11 days)

#### Detail

A surfboard riding competition will be conducted in the navigable waters off Merewether Beach, Newcastle during the above dates and times, and the location as specified above. The area directly around the designated surfboard riding competition may be dangerous and hazardous to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of control vessels stationed on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be monitored and patrolled by control vessels.

#### **REGULATION OF VESSELS – EXCLUSION ZONE**

#### Location

Murray River – between the 888 kilometre river marker and 100 metres further downstream from the landmark of the Mildura Rowing Club, near the township of Mildura (Victoria).

#### Duration

- 7:00am to 7:00pm Saturday 3 April 2021
- 7:00am to 7:00pm Sunday 4 April 2021

#### Detail

A rowing event will be conducted on the navigable waters of Murray River during the above dates and times, and at the location as specified above.

An **EXCLUSION ZONE** is specified during the event, which will be marked by buoys at each end of the zone.

A variety of rowing craft will be competing inside the exclusion zone on a 1 kilometre long course. Buoys will be in place indicating the start and finish of the course.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be monitored and patrolled by control vessels.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

In this Schedule, an eligible pensioner means a person:

- (a) who is entitled to hold any of the following cards issued by the Commonwealth:
  - (i) a card known as a pensioner concession card,
  - (ii) a card known as a gold repatriation health card that is embossed with TPI, EDA, WAR WIDOW or WAR WIDOWER,

**Note**. TPI refers to totally and permanently incapacitated and EDA refers to extreme disablement adjustment.

- (iii) a card prescribed by the regulations as being equivalent to any of those cards, or
- (b) who is entitled to receive, in respect of any injury or disease, a pension, or other amount, approved by the Authority that is payable under the *Veterans' Entitlements Act 1986* of the Commonwealth or the *Military Rehabilitation and Compensation Act 2004* of the Commonwealth, or
- (c) who is a war widow or war widower (within the meaning of section 5E of the *Veterans' Entitlements Act 1986* of the Commonwealth), or
- (d) who is under 16 years of age and named as a dependant on the current New South Wales Pensioner Concession Card in (a) above, or
- (e) who is under 16 years of age and holds a current New South Wales Centrelink Health Care Card.

Vessel operators are advised that a filming event will be held on the navigable waters of Georges River during the above dates and times and at the location specified above.

An **EXCLUSION ZONE** is specified during the event on the waters of Chipping Norton Lake, Georges River at Grand Flaneur Beach within the area defined by the foreshore and a line drawn between Ascot Point and Long Point, which will be monitored by control vessels.


