MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:
- (a) DECLARE the following premises to be declared mental health facility for the purposes of the *Mental Health Act 2007:*
 - The Emergency Department of the Sydney Children's Hospital Randwick located on the campus of the Prince of Wales Hospital Randwick. The Children's Hospital Emergency Department is on the ground floor of the Emergency wing (Building 2A), adjacent to the main building and entrance of the Children's Hospital from High Street, Randwick NSW 2031; and
- (b) DECLARE this facility to be designated as a "mental health emergency assessment class" facility; and
- (c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the Mental Health Act 2007, with the exception of:
- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3; and

MENTAL HEALTH ACT 2007 Section 109 Revocation of Declared Mental Health Facility

- I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, DO HEREBY:
- (a) REVOKE the Order published in the NSW Government Gazette number 74 of the 21 June 2013, declaring the Emergency Departments of the Sydney Children's Hospital Randwick and the Children's Hospital Westmead as declared mental health facilities in the 'mental health emergency assessment' class in accordance with section 109 of the Mental Health Act 2007.

MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:
- (a) DECLARE the following premises to be a declared mental health facility for the purposes of the *Mental Health Act 2007:*
 - The Emergency Department of the Children's Hospital Westmead located on the campus of Westmead Hospital. The Children's Hospital Emergency Department is on Level 2 of Building K (Central Acute Services Building). Building K is located between the Children's Hospital Westmead and Westmead Hospital, on Hawkesbury Road, Westmead NSW 2145; and
- (b) DECLARE this facility to be designated as a "mental health emergency assessment class" facility; and
- (c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the Mental Health Act 2007, with the exception of:
- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3; and
