PART 4 of the Local Land Services Regulation 2014

Local Land Services in accordance with PART 4 of the *Local Land Services Regulation 2014* does hereby make the following determination in respect of the year commencing 1 July 2020:

- **a.** It proposes to raise \$5,375,000 by way of catchment contribution.
- **b.** The catchment contribution is to be levied on all rateable land within the Hunter Catchment Contribution area as delineated by maps held at the Hunter Local Land Services offices.
- **c.** The basis of the catchment contribution is a rate based on land values provided by the appropriate Local Government councils.
- **d.** The catchment contribution rate for the year commencing 1 July 2020 will be **0.00964** of a cent in the dollar (land value).
