#### Part 1 Preliminary

#### 1. Name of Instrument

This Instrument is the *Fisheries Management (Fishing Determination – Spanner Crab) Notification 2021.* 

### 2. Interpretation

In this Instrument:

*Ocean Trap and Line Fishery* means the share management fishery of that name, as described in Schedule 1 to the Act.

*Ocean Trap and Line Plan* means the Appendix to the Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006.

spanner crab means the species Ranina ranina.

**TAC determination** has the same meaning as in section 40A of the Act.

TAF Committee means the Total Allowable Fishing Committee.

the Act means the Fisheries Management Act 1994.

## 3. Notice of TAC determination the Ocean Trap and Line Fishery
