#### MARINE NOTICE

#### Section 12(2)

#### REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

#### Location

Kiama Harbour, Tasman Sea – adjacent to the Kiama Breakwall on the northern side of the Kiama Boat Harbour.

#### Duration

• 6:00pm to 8:00pm – Saturday 19 June 2021

#### Detail

A fireworks display will be conducted over the navigable waters of Kiama Harbour and the adjacent waters of the Tasman Sea as specified above. The display will be staged from land at the above location. The area directly around this location may be dangerous and hazardous while the fireworks display is occurring.

An **EXCLUSION ZONE** is specified during the event extending for a radius of 200 metres around the display. The zone will be indicated by the presence of control vessels stationed on the perimeter.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

#### **Special Restrictions**

Pursuant to section 12(3) of the *Marine Safety Act 1998*, for the duration of the event, special restrictions are imposed on all lawfully moored vessels within the exclusion zone whilst it is in force as follows:

• Vessels moored within the area must remain at their position and MUST NOT be operated during the event.

Penalties may apply (section 12(5) - Marine Safety Act 1998)
