#### SCHEDULE “C”

##### 1. **Development Consent**

All works and activities in accordance with a current and valid development consent in force at the date of gazettal on the State Heritage Register.

##### 2. **Temporary Structures**

Placement of temporary structures (including fencing, signage, portable lavatories and marquees associated with special events (tours, open days etc.) providing that the structures are erected within and used for a maximum period of 4 weeks after which they will be removed within a period of 4 days and not erected again within a period of 1 month.

### **3. Shipping Containers**

Placement of shipping containers or other temporary/moveable infrastructure associated with the business use of the item providing that these are placed on the northern portion of the curtilage where possible.

### **4. Drainage Installation/Maintenance and Flood Control Works**

- a) drainage maintenance and installation;
- a) excavation for the purposes of drainage or flood control works where there is no known or suspected archaeological relics and where works do not adversely impact the significance of any known or likely heritage item.

Note: This exemption does not apply if archaeological relics are likely to be present as advised by a suitably qualified and experienced archaeologist.

### **5. Safety Works**

All internal works associated with the installation or upgrade of safety related fittings, fixtures and equipment (such as ventilation and fire safety systems, benches shelving, storage units, equipment securing etc).

### **6. Internal Works**

All internal works within the hangar (such as standalone structures, fittings and fixtures) providing these:

- a) utilise existing conduits where possible;
- b) do not have an adverse effect on significant fabric;
- c) are able to be later removed without causing damage to significant fabric.

### **7. Pest Control and Remediation**

All internal works associated with pest control (such as white ants) including replacement of affected timber providing these works do not have an adverse effect on significant fabric.

### **8. Signage**

Installation of temporary and wayfinding signage, exit signs and business name signs provided that they:

- a) be located and be of a suitable size so as not to obscure views to significant buildings or damage significant fabric;
- b) be able to be later removed without causing damage to significant fabric; or
- c) reuse existing fixing points or insert fixings within existing mortar joints without damage to adjacent masonry.

### **9. Road and Carpark Works**

The following road, car parking, and traffic management work where there is no adverse impact on heritage significance:

- a) installation, repair, renewal or removal of kerbing/edging, signage, line work, traffic/pedestrian safety bollards, wheel stops and minor access ramps; or
- b) resurfacing of existing gravel road/tracks and car park surfaces.

### **10. Agricultural Fencing**

The installation, repair, renewal or removal of agricultural or stock control fencing where works do not adversely impact the significance of any known or likely heritage item.

## **11. Grazing**

The grazing of livestock for grass suppression purposes in the agricultural fields within the State Heritage Register curtilage.

## **12. Asbestos Control and Remediation Measures**

Asbestos control and remediation measures such as:

- a) minor stabilisation works or removal of unstable fabric;
- b) minor replacement of asbestos with an alternative safe material of matching profile and aesthetic to prevent water ingress;
- c) where works do not adversely impact the significance of any known or likely heritage item.

Note: does not include the large-scale replacement of asbestos cladding (such as the roof and external walls).

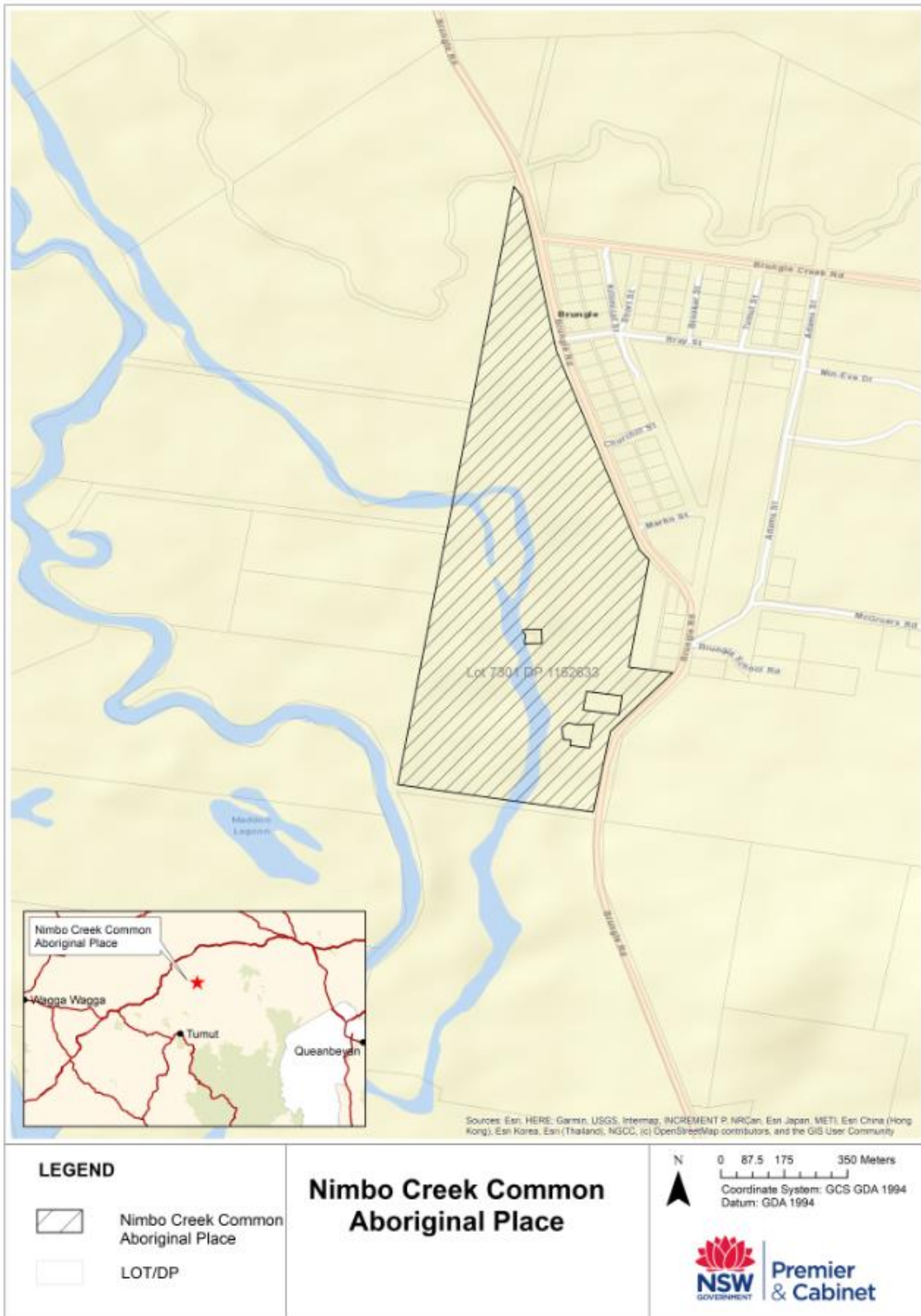

#### SCHEDULE “C”

1. Maintenance and cleaning of the jetty fabric to retain condition and operation without removal or damage of existing fabric and without introduction of new materials.
2. Repair of damaged or deteriorated fabric that is beyond further maintenance, with new fabric which matches the original fabric in appearance, material (species if feasible), configuration/alignment and method of affixing and does not have an impact upon the heritage significance of the jetty. Prior to commencement, the work must be included in a Part V Assessment which includes a Heritage Impact Statement and the works must be documented with an archival record.

3. All repairs, replacement and/or modification of elements introduced for operational requirements (being lighting, handrails, seating and similar) using like-for-like materials and colour schemes and maintaining existing configuration.
4. Removal of elements introduced for operational requirements (being lighting, handrails, seating and similar) if there is no impact on the heritage significance of the jetty and does not involve damage to or removal of existing fabric.
5. Replacement of services that use existing service routes, cavities or voids or replaces existing surface mounted services and does not involve damage to or removal of significant fabric.
6. All repairs, replacement, installation and/or modification of security and safety measures if there is no impact on the heritage significance of jetty.
7. All repairs, replacement and/or modification of non-illuminated emergency, safety, or urgent law enforcement signage if there is no impact on the heritage significance of the jetty.
8. All repairs, replacement and/or modification of interpretation signage if there is no impact on the heritage significance of the jetty.
9. Holding of events by Coffs Harbour City Council (or approved by Coffs Harbour City Council) within the Coffs Harbour Jetty curtilage as often as deemed appropriate by Coffs Harbour City Council if there is no impact on the heritage significance of the jetty.
10. Installation of temporary event-related structures for a period not exceeding fourteen (14) days for events held by Coffs Harbour City Council (or approved by Coffs Harbour City Council) as often as deemed appropriate by Coffs Harbour City Council if there is no impact on the heritage significance of the jetty.

These site specific exemptions do not exempt the need for approvals under different legislation (e.g. *Environmental Planning and Assessment Act 1979*).

If any unexpected historical archaeological deposits and/or relics or Aboriginal objects are discovered, works must cease in the affected area(s) and notification made immediately in accordance with the *Heritage Act 1977 (NSW)* and the *National Parks and Wildlife Act 1974 (NSW)*.

Prior to any works being undertaken in accordance with these site-specific exemptions, the impact on the Aboriginal cultural heritage values of the place is to be assessed by a person with culturally appropriate knowledge of the place, as deemed suitable by the Wee Waa Local Aboriginal Land Council.



1. Installation of commemorative monuments, markers, structures or items if the design, scale and appearance is considered appropriate by Wee Waa Local Aboriginal Land Council and the structural integrity and placement is considered appropriate by Narrabri Shire Council.
2. All works to repair, maintain and/or remove commemorative monuments, markers, structures or items.
3. Installation of interpretation signage if the design, scale and appearance is considered appropriate by Wee Waa Local Aboriginal Land Council and the structural integrity and placement is considered appropriate by Narrabri Shire Council.
4. All works to repair, maintain and/or remove interpretation signage.
5. Installation of emergency, safety or urgent law enforcement signage.
6. All works to repair, maintain and/or remove emergency, safety, or urgent law enforcement signage.
7. Any activities to collect, remove and/or relocate Aboriginal objects or remains in or outside of the site.
8. Any activities to repatriate Aboriginal objects or remains to or within the site.
9. Any revegetation works.
10. Any bank stabilisation work.
11. All landscaping works.
12. Installation of post and wire fence along accessway.
13. Maintenance and/or removal of post and wire fence along accessway.
14. Installation of gate at Millie Road entrance. Style and scale of gate to be consistent with other gates used in the region and consistent with the agricultural setting of the place.
15. Maintenance and/or removal of gate at Millie Road entrance.
16. All works to maintain unsealed or all-weather accessway with associated drainage.
17. Installation of temporary structures for events for a period of time considered appropriate by Wee Waa Local Aboriginal Land Council.
