Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to City of Sydney Council to advertise, designate and recruit the positions of Senior Community Engagement Coordinator and Community Engagement Coordinator (Eora Journey) for Aboriginal or Torres Strait Islander persons only.

This exemption will remain in force for 5 years.
