1 Name of Order

This Order is the Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Amendment (No 9) Order 2021.

2 Amendment of Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021

(1) Clause 3 Definitions

Insert ", or at which civil works are being carried out," after "structure" in the definition of *construction site* in clause 3(1).

 $(2) \qquad \hbox{Clause 22AA Direction of Minister concerning person leaving Greater Sydney}$

Omit "A person". Insert instead "The Minister directs that a person".

(3) Clause 24AA Directions of Minister about use of vehicles

Omit "18 years" from clause 24AA(3). Insert instead "16 years".

(4) Clause 24AB Directions of Minister concerning closure of construction sites

Omit clause 24AB(1)(c). Insert instead—

(c) to maintain and ensure the integrity of critical plant, equipment or assets, including partially completed works, that would otherwise deteriorate,

(5) Clause 24B Directions—testing of workers from affected areas

Insert after clause 24B(1)—

- (1A) If the Chief Health Officer specifies, by notice published on the website of NSW Health, a particular category of worker to whom this clause applies, this clause applies only to an affected worker who belongs to the particular category.
- (6) Subclause (4) commences at the beginning of 19 July 2021.
