Explanatory note

The object of this Order is to amend the Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) 2021-

- (a) to make further provision concerning the holding of, and attendance at, small wedding services, and
- (b) to make it clear that the direction preventing workers in areas of concerns from leaving the areas to work is limited to workers who live in the areas.

1 Name of Order

This Order is the Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 4) Order 2021.

2 Commencement

- (1) This Order commences when the Minister signs the Order, except as provided by subclause (2).
- (2) Schedule 1[1], [3], [4] and [5] commence at the beginning of 3 September 2021.

[1] Clauses 3.4(2)(c), 3.13(2)(b)(vi), 4.5(2)(c), 4.14(2)(b)(vi) and 5.2(2)(d)

Insert "or small wedding service" after "small funeral or memorial service" wherever occurring.

[2] Clause 4.3 Leaving area of concern for work

Omit "whose place of residence is in an area of concern" from clause 4.3(1).

Insert instead "who lives in an area of concern".

[3] Schedule 2, clause 21A

Insert after clause 21—

21A Small wedding service

- (1) A person may leave the person's place of residence to attend a small wedding service if the person is—
 - (a) a person who is legally necessary for the conduct of the service, or Examples— The persons getting married, the person marrying them and the witnesses.
 - (b) the person who is recording the service.
- (2) A person to whom subclause (1) does not apply may leave the person's place of residence to attend a small wedding service if—
 - (a) the service is in the stay at home area, or
 - (b) for a service outside the stay at home area—the person is the parent, child or sibling of 1 of the persons getting married.
- (3) This clause does not allow a person who resides in Greater Sydney to attend a small wedding service held outside Greater Sydney.

[4] Schedule 2, clause 26

Insert after clause 25-

26 Small wedding service

- (1) A person may leave the person's place of residence to attend a small wedding service if the person is—
 - (a) a person who is legally necessary for the conduct of the service, or Examples— The persons getting married, the person marrying them and the witnesses.
 - (b) the person who is recording the service.
- (2) A person to whom subclause (1) does not apply may leave the person's place of residence to attend a small wedding service if—
 - (a) the service is in the area of concern, or
 - (b) for a service outside the area of concern—the person is the parent, child or sibling of 1 of the persons getting married.

(3) This clause does not allow a person who resides in Greater Sydney to attend a small wedding service held outside Greater Sydney.

[5] Schedule 4 Dictionary

Insert in alphabetical order-

small wedding service means a wedding service, but not a gathering after a wedding service, at which there are no more than 5 persons, excluding—

- (a) the persons legally necessary for the conduct of the service, and Examples— The persons getting married, the person marrying them and the witnesses.
- (b) 1 person to record the service.
