#### **GEOGRAPHICAL NAMES ACT 1966**

PURSUANT to the provisions of Section 8 of the *Geographical Names Act 1966*, the Geographical Names Board hereby notifies that it proposes to create eight new Address Localities (suburbs) in the Blue Mountains National Park, Wollondilly LGA.

The proposal is to create new suburbs named *Kowmung, Beloon, Jooriland, Burragorang Valley, Brereton, Kedumba, Bindook* and *Bimlow*.

The position and extent for these features are recorded and shown within the Geographical Names Register of New South Wales.
