[1] Clauses 3.20(1) and 4.21(1)

Omit "the premises" wherever occurring. Insert instead "real estate".

[2] Clause 4.3 Leaving area of concern for work

Omit clause 4.3(3C) and (3D). Insert instead—

- (3B) Subclauses (3) and (3A) do not apply to an authorised worker before 9 September 2021.
- (3C) From the beginning of 9 September 2021 until the end of 19 September 2021—
 - (a) an authorised worker is taken to comply with subclause (3) if the authorised worker has an appointment to receive a COVID-19 vaccine on or before 19 September 2021, and
 - (b) evidence of the appointment is taken to be the worker's vaccination evidence for the purposes of the required evidence in subclause (3A).
- (3D) This clause does not apply to a person if the person has not been in the area of concern during the previous 14 days.

[3] Clause 4.24 Vaccinations—early education and care and disability support

Insert after clause 4.24(3)—

- (3A) Subclauses (2) and (3) do not apply to a relevant care worker before 9 September 2021.
- (3B) From the beginning of 9 September 2021 until the end of 19 September 2021—
 - (a) a relevant care worker is taken to comply with subclause (2) if the relevant care worker has an appointment to receive a COVID-19 vaccine on or before 19 September 2021, and
 - (b) evidence of the appointment is taken to be the worker's vaccination evidence for the purposes of the required evidence in subclause (3).

[4] Clause 4.24(5)

Omit the subclause.
