Section 318B

ORDER

Postponement of elections for Wingecarribee Shire Council

I, the Hon Shelley Hancock MP, Minister for Local Government, in pursuance of section 318B(1)(a)(ii) of the *Local Government Act 1993* (the Act), do hereby order that the election requirements of the Act in relation to the ordinary election that was due to be held on 4 December 2021 for Wingecarribee Shire Council be postponed from the date of this Order until twelve months after this Order is made by reason that the Council is the subject of a public inquiry under section 438U of the Act.

For the avoidance of doubt, the postponement of the ordinary election extends to and suspends an election requirement for a by-election referred to in section 292 of the Act arising between the date of this Order and the date of the ordinary election.
