This Order is the Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 10) Order 2021.

2 Commencement

This Order commences-

- (a) for Schedule 1[3], clause 3, table, items 3 and 4—16 September 2021 at 6pm, or
- (b) otherwise—16 September 2021 at 1pm.

[1] Clause 3.2 Staying at home

Omit clause 3.2(5), definition of *relevant date*. Insert instead—

relevant date means—

- (a) for a new stay at home area—
 - (i) the date on which the area became a stay at home area, or
 - (ii) if Schedule 1 specifies an earlier date for the stay at home area the earlier date, or
- (b) if an area becomes part of an existing stay at home area—
 - (i) the date on which the area became part of the stay at home area, or
 - (ii) if Schedule 1 specifies an earlier date for the area—the earlier date.

[2] Clause 7.6 Amendment of this Order

Omit the clause.

[3] Schedule 1 Categories of area

Omit clause 3. Insert instead—

3 Regional NSW area

- (1) The regional NSW area is a stay at home area, other than a part of the regional NSW area that is an area of concern.
- (2) The *regional NSW area* comprises the local government areas set out in column 1 of the table to this clause.
- (3) The relevant date for the purposes of clause 3.2(5) is the date set out in column 2 of the table.
- (4) A local government area ceases to be part of the regional NSW area at the beginning of the day on the date set out in column 3 of the table.
