1 Name of Order

4 Amendment of Shannon Creek Dam Notification Area

This Order amends the *Shannon Creek Dam* Notification Area declared by the Shannon Creek *Dam* Order 24 April 2014 as described in Schedule 1.

Explanatory note

Section 5(1) of the *Dams Safety Act 2015* provides that Dams Safety NSW may, by order published in the Gazette, declare a dam or proposed dam to be a declared dam for the purposes of the Act.

Section 43(2) of the *Interpretation Act 1987* provides that, if an Act or statutory rule confers a power on any person or body to make an order (whether or not the order must be in writing), the power includes power to amend or repeal any order made in the exercise of that power.

This order amends the *Declared Dams Order 2021* so that the dams in Schedule 1 to this Order are declared to be declared dams for the purposes of the *Dams Safety Act 2015*.

The dams in Schedule 2 to this Order were declared to be declared dams for the purposes of the *Dams Safety Act 2015* by the *Declared Dams Order 2021* (published in the NSW Government Gazette No. 164 of 23 April 2021).

This order amends the *Declared Dams Order 2021* so that the dams in Schedule 2 to this Order are no longer declared to be declared dams for the purposes of the *Dams Safety Act 2015*.
