ERRATUM

Erratum notice for Government Gazette No 445, published 10 September 2021: Under the heading 'Renewal of Certain Authorities' it was listed that the renewal of Exploration Licence 7162 was for a further term until 23 June 2027. This renewal was in fact for a further term until 23 June 2024.

Ministerial Direction under section 20P of the *State Owned Corporations Act 1989*

On 20 August 2021 I, as portfolio Minister for the Forestry Corporation of NSW (FCNSW), with approval of the Treasurer, issued a Direction to FCNSW under section 20P of the *State Owned Corporations Act 1989* (SOC Act) to divert selected softwood log exports to domestic markets and to transport those logs primarily using rail (the Direction).

The reasons for issuing the Direction were:

- the impact of the 2019/2020 bushfires on standing timber resources in NSW,
- the current ban of Australian log exports to China,
- increasing demand for timber in the construction sector at a time when supply from imports is decreasing due to global market forces.

The Direction is in the public interest because:

- diverting timber that would otherwise be exported will minimise employment impacts on sawmills in bushfire-affected regions;
- diverting timber that would otherwise be exported will alleviate the flow-on impacts
 on the construction sector and the cost of housing arising from the shortage of
 construction timber;
- using rail transport for the diverted timber will minimise local employment impacts by ensuring an existing intermodal is used; and
- using rail transport for the diverted timber avoids the risks of significantly increased truck movements in impacted areas of the State.
