1 Name of Order

This Order is the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 12) Order 2021.*

2 Commencement

- (1) This Order commences at the beginning of 20 September 2021, except as provided by subclause (2).
- (2) Schedule 1[1] and [5] commence at the beginning of 27 September 2021.

[1] Clause 3.3 Premises that must not be open

Omit clause 3.3(h).

[2] Clause 3.12 Other persons authorised to visit place of residence

Omit clause 3.12(3)(c). Insert instead—

- (c) the individual resides in—
 - (i) the stay at home area, or
 - (ii) for a stay at home area in Greater Sydney—Greater Sydney.

[3] Clause 3.12(5)

Omit the subclause.

[4] Clause 4.3 Leaving area of concern for work

Insert at the end of clause 4.3(4), definition of *required evidence*, paragraph (b)—

, and

(c) a permit issued by Service NSW, if required.

[5] Clause 4.4 Premises that must not be open

Omit clause 4.4(h).

[6] Clause 4.13 Other persons authorised to visit place of residence

Omit clause 4.13(3)(c). Insert instead—

(c) for an area of concern in Greater Sydney—the individual resides in Greater Sydney.

[7] Clause 4.13(3), note

Omit the note to clause 4.13(3).

[8] Clause 4.13(5)

Omit the subclause.

[9] Clause 4.14 Maximum number of persons—outdoor public gatherings

Omit clause 4.14(1). Insert instead—

- (1) A person must not participate in an outdoor public gathering in an area of concern of more than—
 - (a) if all persons participating in the gathering who are at least 16 years of age are fully vaccinated—5 persons, not including persons who are 12 years of age and under, or
 - (b) otherwise—2 persons.
- (1A) A person who is at least 16 years of age and participating in an outdoor public gathering in an area of concern of more than 2 persons must—
 - (a) carry vaccination evidence for the person, and

Example— An online immunisation history statement or COVID-19 digital certificate from the Australian Immunisation Register.

(b) produce the evidence if requested to do so by a police officer.

[10] Clause 4.24 Vaccinations—early education and care and disability support

Insert at the end of clause 4.24(4), definition of *required evidence*, paragraph (b)—

(c) a permit issued by Service NSW, if the person is required to have the permit to enter or leave an area of concern for work.

[11] Clause 5.2 Entering Greater Sydney

Omit "other than clause 9" from clause 5.2(2)(b).

Instead "other than clauses 9, 18 and 19".

[12] Clause 5.2(2)(d)

Omit the paragraph.

[13] Clause 5.8 Vaccination required to work on construction sites in Greater Sydney

Insert after clause 5.8(6), definition of *required evidence*, paragraph (a)—

(a1) a permit issued by Service NSW, if the person is required to have the permit to enter or leave an area of concern for work, and

[14] Clause 7.1, heading

Omit the heading. Insert instead—

7.1 Travelling through State or stay at home areas

[15] Clause 7.1(1A)

Insert after clause 7.1(1)—

- (1A) Clauses 3.2(1) does not apply to a person who has been in a stay at home area during the previous 14 days only because the person—
 - (a) was travelling through the area in a vehicle and did not leave the vehicle while in the area, or
 - (b) was travelling through the area by road by the most practicable direct route.

[16] Schedule 2 Reasonable excuses

Omit Parts 2 and 3.

[17] Schedule 2, clauses 18–21

Insert after clause 17—

18 Obtaining goods and services

- (1) A person may leave the person's place of residence to obtain goods or services if the goods or services—
 - (a) are for the personal needs of the person's household or for other household purposes, including for vulnerable persons or pets, and
 - (b) are obtained locally, unless the goods or services, or equivalent goods or services, are not reasonably available locally.

Note— Browsing in a shop is not authorised by this clause.

Schedule 1 Amendment of Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) 2021

- (2) Unless it is not reasonably practicable, a person must not leave the person's place of residence under this clause if a member of the person's household, including the person, has already left the place of residence on that day to obtain goods or services.
 - **Example—** A person would be permitted to be accompanied by a dependant if it were not reasonably practicable for the dependant to remain at home.
- (3) A person who is at least 16 years of age who leaves the person's place of residence under this clause must—
 - (a) carry evidence showing the person's name and place of residence, and
 - (b) produce the evidence if requested to do so by a police officer.
- (4) In this clause—

locally means—

- (a) within the local government area in which the person resides, or
- (b) if within another local government area—
 - (i) no further than 5 kilometres from the person's place of residence, and
 - (ii) for a person who resides in a stay at home area—not in an area of concern.

19 Exercise or outdoor recreation

- (1) A person may leave the person's place of residence to undertake exercise or outdoor recreation if it is undertaken—
 - (a) within the local government area in which the person resides, or
 - (b) if within another local government area—no further than 5 kilometres from the place of residence.

Example— This applies to leisure activities, including fishing.

- (2) A person who is at least 16 years of age who leaves the person's place of residence under this clause must—
 - (a) carry evidence showing the person's name and place of residence, and
 - (b) produce the evidence if requested to do so by a police officer.

20 Wedding service

- (1) A person may leave the person's place of residence to attend a wedding service, but only if there are no more than the maximum number of persons permitted by this Order at the service.
- (2) Despite subclause (1), a person must not leave the person's place of residence to attend a wedding service in the general area unless the person is the parent, child or sibling of 1 of the persons getting married.
- (3) This clause does not allow a person who resides in Greater Sydney to attend a wedding service held outside Greater Sydney.

21 Funeral or memorial service

- (1) A person may leave the person's place of residence to attend a funeral or memorial service, but only if there are no more than the maximum number of persons permitted by this Order at the service.
- (2) Despite subclause (1), a person must not leave the person's place of residence to attend a funeral or memorial service in the general area unless the person is the spouse, de facto partner, parent, child or sibling of the deceased person.

[18] Schedule 4 Dictionary

Omit the definition of *nominated visitor*. Insert instead—

nominated visitor means a person nominated as a nominated visitor under clause 3.12 or 4.13.
