### **EXEMPTION ORDER**

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Maitland City Council to advertise, designate and recruit one Environmental Health Officer cadet for an Aboriginal and Torres Strait Islander person only.

This exemption will remain in force for 6 years.
