Explanatory note

The objects of this Order are—

- (a) to temporarily include in the regional NSW stay at home area—
 - (i) the local government area of Gunnedah, and
 - (ii) the suburbs in the local government area of Mid-Coast with the postcode 2428 or 2430, and
- (b) to temporarily extend the period during which Muswellbrook local government area remains in the regional NSW stay at home area.

This Order also removes some expired provisions and makes other minor amendments.

This Order is the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 25) Order 2021.*

2 Commencement

This Order commences at the beginning of 5 October 2021.

3 Amendment of Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) 2021

(1) Schedule 1 Categories of area

Insert "or parts of local government areas" after "local government areas" in clause 3(2).

(2) Schedule 1, clause 3(2A) and (2B)

Omit the subclauses.

(3) Schedule 1, clause 3(4)

Insert "or part of a local government area" after "local government area".

(4) Schedule 1, clause 3, table, items 2, 5, 6 and 8-10

Omit the items.

(5) Schedule 1, clause 3, table, item 12

Omit "6 October 2021". Insert instead "11 October 2021".
