1 Name of Order

This Order is the Public Health (COVID-19 Air Transportation Quarantine) Order (No 3) Amendment Order 2021.

2 Commencement

This Order commences at the beginning of 1 November 2021.

Schedule 1 Amendment of Public Health (COVID-19 Air Transportation Quarantine) Order (No 3) 2021

[1] Clauses 8 and 9

Omit the clauses.

[2] Clause 10 Persons arriving in NSW by land

Omit "or New Zealand" from clause 10(1)(b).

[3] Clause 10(4)(a)

Omit "quarantined person to whom a direction is given under clause 7 or 9". Insert instead "relevant person to whom a direction is given under clause 7".

[4] Clause 11 Entering, remaining and departing quarantine or medical facilities

Omit "quarantined person" and "clause 7 or 9" wherever occurring.

Insert instead "relevant person" "and "clause 7", respectively.

[5] Clause 12 Wearing of fitted face coverings

Omit "quarantined person" from clause 12(1).

Insert "relevant person".

[6] Clause 35 Transitional provisions for Public Health Amendment (COVID-19 Border Provisions) Order 2021 (as inserted by the Public Health Amendment (COVID-19 Border Provisions) Order 2021)

Omit clause 35(1)(c). Insert instead—

(c) chooses to remain in a quarantine facility until the end of the quarantine period.

[7] Clause 35(2) (as inserted by the Public Health Amendment (COVID-19 Border Provisions) Order 2021)

Omit "a quarantined person". Insert instead "in a quarantine facility".

[8] Schedule 1 Dictionary

Omit the definitions of New Zealand COVID-19 hotspot and quarantined person.

[9] Schedule 1, definition of "relevant flight crew member"

Omit the definition. Insert instead-

relevant flight crew member means a flight crew member who-

- (a) arrives in New South Wales by aircraft, whether the flight originates interstate or overseas, as a flight crew member, and
- (b) has, within 14 days immediately before the crew member's arrival, been in a country other than Australia.

[10] Schedule 1, definition of "relevant person"

Omit the definition. Insert instead—

relevant person means-

(a) a person who—

- (i) arrives in New South Wales by aircraft, whether the flight originates interstate or overseas, and
- (ii) has, within 14 days immediately before the person's arrival, been in a country other than Australia, or
- (b) a relevant flight crew member.
