MINING REGULATION 2016 EXEMPTION FROM MINING ACT 1992 SECTION 6 (OPAL PUDDLING) ORDER 2021 under the MINING REGULATION 2016

I, GEORGINA BEATTIE, Deputy Secretary of Mining, Exploration and Geoscience, Department of Regional NSW with the delegated authority of the Deputy Premier, Minister for Regional NSW, pursuant to clause 11 of the Mining Regulation 2016 (Regulation), exempt the class of persons specified in Column 1 of Schedule 1 below from the operation of section 6 of the *Mining Act 1992* (Act) with respect to the carrying out of the class of designated ancillary mining activities specified in Column 2 of Schedule 1, where those activities are being carried out at a location specified in Column 3.

This Order takes effect on the day that it is published in the New South Wales Government Gazette (Gazette) and will cease to have effect on the date that is 2 years from the day this Order is published in the Gazette, unless it is repealed before that date.

Unless otherwise stated, words and expressions that are defined in the Act or the Regulation have the same meaning in this Order.

MINING REGULATION 2016 EXEMPTION FROM MINING ACT 1992 SECTION 163C(1) (OPAL PROSPECTING REPORTING) ORDER 2021 under the MINING REGULATION 2016

I, GEORGINA BEATTIE, Deputy Secretary of Mining, Exploration and Geoscience, Department of Regional NSW with the delegated authority of the Secretary of the Department of Regional NSW, pursuant to clause 68(1) of the Mining Regulation 2016 (Regulation), exempt the class of persons specified in Column 1 of Schedule 1 below from complying with the conditions of an opal prospecting licence specified in Column 2 of Schedule 1.
