MENTAL HEALTH ACT 2007
Section 109
Declaration of mental health facility

I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007* and section 43 of the *Interpretation Act 1987*, DO HEREBY:

(a) REVOKE the Order published in the NSW Government Gazette No. 81 of 7 August 2012, declaring three community entities as declared mental health facilities in accordance with section 109 of the *Mental Health Act 2007*, and

(b) DECLARE the **Child and Adolescent Community Mental Health Service Newcastle**, situated at 621 Hunter Street, Newcastle NSW 2300, to be a declared mental health facility under the *Mental Health Act 2007*; and

(c) DECLARE the **Child and Adolescent Community Mental Health Service Lake Macquarie**, situated at 1a Dudley Road, Charlestown NSW 2291, to be a declared mental health facility under the *Mental Health Act 2007*; and

(d) DECLARE the **Child and Adolescent Community Mental Health Service Hunter Valley**, situated at Melbee House, Maitland Hospital, 550-560 High Street, Maitland NSW 2320, to be a declared mental health facility under the *Mental Health Act 2007*; and

(e) DECLARE these facilities to be designated in the class of facilities known as “community or health care agency class” for the purposes of section 109 (2)(a); and

(f) RESTRICT these facilities to the provision of services and performance of functions necessary for or associated with the administration or management of community treatment orders under the following provisions of the *Mental Health Act 2007*:

- i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);
- ii. Chapter 4; and
- iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2)

MENTAL HEALTH ACT 2007
Section 109
Declaration of mental health facility

I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007* and section 43 of the *Interpretation Act 1987*, DO HEREBY:

(a) REVOKE the Order published in the NSW Government Gazette No. 97 of 30 June 2009, declaring certain premises of the Mater Hospital Newcastle to be a declared mental health facility in accordance with section 109 of the *Mental Health Act 2007*, and

(b) DECLARE the following premises of the **Hunter New England Mental Health – Mater Mental Health Centre, Edith Street, Waratah NSW 2298** to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:

The following units and courtyards of the **Mater Mental Health Centre**:

- **Mental Health and Substance Use Services Unit**, Level 2;
- **Mental Health Services for Older People Unit**, Level 2;
- **Newcastle Mental Health Unit**, Level 3;
- **Lake Macquarie Mental Health Unit**, Level 3;
- **Mental Health Intensive Care Unit (MHICU)**, Level 3;
- **Psychiatric Emergency Care Centre (PECC)**, Level 3; and

(c) DECLARE this facility to be designated as a “**mental health assessment and inpatient treatment**” facility.
