1. Name of Order

This Order is the *Game and Feral Animal Control (Suspension of Game Hunting Licence Conditions) Order (No.1)* 2021.

2. Commencement

This Order commences on the date it is published in the NSW Government Gazette.

3. Definitions

In this Order:

game animal has the same meaning as in the Act.

game hunting licence has the same meaning as in the Act.

Local Land Services Region is a region described or identified in Schedule 1 of the *Local Land Services Act 2013*

Regulatory Authority has the same meaning as in the Act.

the Act means the Game and Feral Animal Control Act 2002.

the Regulation means the Game and Feral Animal Control Regulation 2012.

4. Suspension of certain conditions of game hunting licences

Pursuant to clause 18(2) of the Regulation, the operation of subclauses 5(1) and 6(1) of Schedule 1 to the Regulation, are suspended-

- (a) for the period from 16 November 2021 to 15 November 2026 (both dates inclusive), and
- (b) in relation to the land specified in Schedule 1, being land that the Regulatory Authority is satisfied is the subject of a management plan dealing with the management, control or eradication of game animals.

Schedule 1 Land

The lands consisting of:

- (a) All lands within the North Coast Local Land Services Region.
- (b) All lands within the Northern Tablelands Local Land Services Region.
- (c) All lands within the North West Local Land Services Region.
- (d) All lands within the Western Local Land Services Region.
- (e) All lands within the Hunter Local Land Services Region.
- (f) All lands within the Central Tablelands Local Land Services Region.
- (g) All lands within the Central West Local Land Services Region.
- (h) All lands within the Greater Sydney Local Land Services Region.
- (i) All lands within the South East Local Land Services Region.
- (j) All lands within the Riverina Local Land Services Region.
- (k) All lands within the Murray Local Land Services Region.
