Explanatory note

The object of this Order is to approve river gauges of specified types and designs for the purpose of measuring the level or flow of water in rivers located in specified water sources to which the *Water Sharing Plan for the Murrumbidgee Unregulated River Water Sources 2012* applies.

This Order is made under section 367 (5) of the *Water Management Act 2000*.

Approved River Gauge Order 2021

1 Name of Order

This Order is the *Approved River Gauge Order 2021*.

2 Commencement

This Order commences on publication in the NSW Government Gazette.

3 Approved river gauge

This Order approves the river gauges identified in column 1 of the table in Schedule 1 to this Order, of the type or design specified in the corresponding row of column 2 of that table, for the purpose of measuring the level or flow of water in a river in the water source or sources specified in the corresponding row of column 3 of that table.

4 Interpretation

In this Order:

- (1) The water sources identified in column 3 of the table in Schedule 1 to this Order have the same meaning as in the *Water Sharing Plan for the Murrumbidgee Unregulated River Water Sources 2012*.
- (2) **AHD** means Australian Height Datum.
- (3) Unless otherwise defined, words and expressions that are defined in the *Water Management Act 2000* or in regulations made under that Act have the same meaning in this Order.
