Part 1 Preliminary

1. Name of Notification

This notification is the *Fisheries Management (Ocean Trap and Line Fishery Export Approval – North & South Solitary Islands, Fish Rock, Green Island and Magic Point Fishing Closure) Notification 2021*.

2. Commencement and duration

This notification commences on the date it is published in the NSW Government Gazette and will remain in force for a period of five years.

3. Definitions

In this notification:

burleying means any activity that would be reasonably likely to result in the aggregation of fish.

drift line has the same meaning as in clause 2 of the *Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006*.

gang of hooks means a group of hooks, each of which is attached to, and in direct contact with, at least one other of those hooks.

hand held line means a rod (or pole) and line or handline.

lead line means a hand held line where weights may be placed on the line and one hook or a gang of hooks with bait (dead or alive) is used.

lead lining means the use of a lead line deployed from a boat that is making way (that is, a boat that is under active propulsion).

line fishing means the use of a hand held line, set line or drift line.

Ocean Trap and Line Fishery has the same meaning as in Schedule 1 to the Act.

set line has the same meaning as in clause 2 of the *Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006*.

spinning means the use of an artificial fly or lure in connection with a hand held line deployed from a boat that is not making way (that is, a boat that is anchored, moored or otherwise held stationary), in a manner whereby the artificial fly or lure is retrieved at or near the surface of the water (that is, the fly or lure must not be allowed to sink prior to retrieval).

the Act means the *Fisheries Management Act 1994*.

trolling means the use of an artificial fly or lure in connection with a hand held line deployed from a boat that is making way (that is, a boat that is under active propulsion).

4. **Revocation of Fisheries Management (Ocean Trap and Line Fishery Export Approval – North & South Solitary Islands, Fish Rock, Green Island and Magic Point) Notification 2020**

Pursuant to section 11 of the Act, the *Fisheries Management (Ocean Trap and Line Fishery Export Approval – North & South Solitary Islands, Fish Rock, Green Island and Magic Point) Notification 2020* published in *NSW Government Gazette* No. 100 of 19 May 2020 at pages 2021 to 2025 is revoked, as is any notification revived as a result of this revocation.

5. **Fishing closure**

Pursuant to section 8 of the Act:

- a) all endorsement holders in the Ocean Trap and Line Fishery are prohibited from taking all species of fish by the methods of fishing specified in Column 1 of Schedules 1, 2, 3 and 4 to this notification, from the waters described opposite in Column 2 of Schedules 1, 2, 3 and 4 for the period specified opposite in Column 3 of Schedules 1, 2, 3 and 4.

Part 1 Preliminary

1. Name of Order

This Order is the *Fisheries Management (Eastern Australian Salmon Possession Limit) Order 2021*.

2. Commencement and duration

This Order commences on 3 December 2021 and will remain in force for five years.

3. Definitions

In this Order:

drift line has the same meaning as in clause 2 of the Estuary General Plan.

Eastern Australian salmon means the species *Arripis trutta*.

endorsement holder has the same meaning as in clause 2 of the Estuary General Plan and clause 2 of the Ocean Hauling Plan.

Estuary general fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

Estuary General Plan means the Appendix to the Fisheries Management (Estuary General Share Management Plan) Regulation 2006.

hand held line means a rod and line or handline.

hauling net (general purpose) means a net as described in clause 15A of the Ocean Hauling Plan.

landing net means a net that complies with the description set out in the Table in clause 11A of the Appendix to the Fisheries Management (Supporting Plan) Regulation 2006, used only as an ancillary aid to the taking of fish with a set line, hand held line or drift line.

Ocean hauling fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

Ocean Hauling Plan means the Appendix to the Fisheries Management (Ocean Hauling Share Management Plan) Regulation 2006.

possession limit means the maximum quantity of fish that a person may have in the person's possession in any specified circumstance.

set line has the same meaning as in clause 2 of the Appendix to the Estuary General Plan.

the Act means the *Fisheries Management Act 1994*.

whole weight means the weight of fish prior to any processing or removal of any part of the fish.

Part 2 Possession limit

4. Possession limit

An endorsement holder in the Estuary general fishery or the Ocean Hauling fishery must not have in their possession during any day or from the time of departure on a fishing trip to the time of return to port (if longer than a day), Eastern Australian Salmon of more than the following amounts:

- (a) 3,000 kg whole weight if taken in the Ocean hauling fishery by use of a hauling net (general purpose) from waters north of Barrenjoey Head; or
- (b) 50 kg whole weight if taken by use of any other net that may be lawfully used to take fish in the Ocean hauling fishery from waters north of Barrenjoey Head; or
- (c) 50 kg whole weight if taken by use of any net that may be lawfully used to take fish in the Estuary general fishery from waters north of Barrenjoey Head; or
- (d) 0 kg if taken by any other lawful method used to take fish in the Estuary general fishery other than a set line, hand held line, a drift line or a landing net when used in conjunction with a set line, hand line or drift line from waters north of Barrenjoey Head.

1. Name of Notification

This notification is the *Fisheries Management (Eastern Australian Salmon Fishing Closure) Notification 2021*.

2. Commencement and duration

This notification commences on 3 December 2021 and will remain in force for a period of five years.

3. Definitions

In this notification:

drift line has the same meaning as in clause 2 of the Estuary General Plan.

Eastern Australian salmon means the species *Arripis trutta*.

endorsement holder has the same meaning as in clause 2 of the Estuary General Plan and clause 2 of the Ocean Hauling Plan.

Estuary general fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

Estuary General Plan means the appendix to the *Fisheries Management (Estuary General Share Management Plan) Regulation 2006*

hand held line means a rod and line or handline.

hauling net (general purpose) means a net as described in clause 15A of the Ocean Hauling Plan.

landing net means a net as described in the Table in clause 11A of the Appendix to the Fisheries Management (Supporting Plan) Regulation 2006, used only as an ancillary aid to the taking of fish with a set line, hand held line or drift line.

Ocean hauling fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

Ocean Hauling Plan means the Appendix to the Fisheries Management (Ocean Hauling Share Management Plan) Regulation 2006.

set line has the same meaning as in clause 2 of the Estuary General Plan.

the Act means the *Fisheries Management Act 1994*.

whole weight means the weight of fish prior to any processing or removal of any part of the fish.

Part 2 Fishing Closure

4. Fishing closure

All endorsement holders in the Ocean Hauling Fishery and the Estuary General Fishery are prohibited from taking Eastern Australian Salmon from all waters north of Barrenjoey Head by any method of fishing unless:

- (a) in the case of endorsement holders in the Estuary general fishery, the fish are taken with a set line, hand held line, drift line, or a landing net when used in conjunction with a set line, hand held line or drift line, or
- (b) during any day or from the time of departure on a fishing trip to the time of return to port (if longer than a day):
 - (i) the fish are taken by endorsement holders in the Ocean hauling fishery using a hauling net (general purpose) and no more than 3,000 kg whole weight is taken; or
 - (ii) the fish are taken using any other net that may be lawfully used to take fish in the Ocean hauling fishery and no more than 50 kg whole weight is taken; or
 - (iii) the fish are taken using any net that may be lawfully used to take fish in the Estuary general fishery and no more than 50 kg whole weight is taken.
